**IX. ASNC Advisor Report**

Edwin: I briefed all this at the executive meeting on Tuesday. Spring semester is a lot more different than Fall semester. Spring involves planning for the next academic year, as well as the ceremonies at the end of the year. We also need to stay focused on elections and how we would want to spend our money next year. We must start recruiting people for taking leadership. I will be preparing you for budgets that a lot of directors I have worked with do not know how to complete and it looks good on resumes to have that experience. The RT system with transportation fee will probably increase \$8 per person. Student trustee elections are on April 18th.

President: I believe if you can go then you should since it is a really good experience and you meet some interesting people and learn a lot from them.

**Administration:** I would like to briefly discuss three things. Firstly, if anyone has any thing they want to talk about in the meetings, it makes life easier if we know beforehand. Also, I will talk to you individually about lounge hours because people did not want to do them.

Edwin: Lounge hours are important so we can help make sure everyone is signing in.

Nathaniel: Regarding elections, Amber and I were thinking about Waba Grill but, since it is costly, our president suggested to have three vendors, such as Chik-Fil-A, Jamba Juice, and Waba Grill, and for the first 150 people that vote, each of the first 50 will get one of those. This will be a one-day event.

**Finance:** I missed some things so the budget is not up to date, but it will be on Tuesday, and we will also be updating next year's budget.

**Activities:** Thank you to everyone for coming and giving balloons at Share the Love. Chill-out will be from 5-8 PM and we will have snow and bouncy houses as well as some food. Send me your Friday schedules so I can make everyone's shifts and remember set up starts at 1.

**Relations:** I have made a bunch of flyers for Men and Women Gender Discussion and the Signature Workshop on February 28 in ST107. The art show will be today after the meeting with live performances and food. We are thinking of making a new logo for ASNC and shirts. We will be doing an event for St. Patrick's Day like an event questionnaire and people will be getting prizes such as shirts and bottles. I will be taking everyone's pictures individually until next Thurs.

**Organizations:** Club Rush is next week from Tues. to Thurs, 9AM-2PM. Come and help out with the booth by answering students' questions. The Town Hall meeting is tomorrow from 2-6PM which is mandatory for one representative to be there.

Edwin: Why is it mandatory?

MK: It is not but it is a good experience and will make you stand out.

**President:** Director fought for library hours and Dr. Reece was embarrassed that we did not have enough study space so, he wants to open all the rooms from 8AM-10PM. I have a meeting with Dr. Lee and Dr. Collins for their approval for this and the goal is to have all the classrooms open for us by spring break, except for chemistry labs. I am trying to go to TA Board to pledge a bit but must see when their meetings are. We also talked about the student fee increases and Dr. Reece sees us doing good things with it. I told him we will be

cutting funds for sports from ASNC to see if the school can pay instead of us and we will be having a meeting to discuss that. April 18th. there will be a dinner with the President. For us, to sponsor a table it will be \$800 dollars for 8 students to go. We will also be making packages to send across seas for troops. The General Assembly will be from April 5th-7th and we would leave on the 4th. Myself, as well as MK will be going and for the other two students there will be applications available soon. Adrianna needs help for student panels and campus tours on Fridays 10AM-11:30AM, including tomorrow. If anyone is interested in running for president and would like to shadow me, let me know. Ruth made a video of me to welcome students and I will send it to you all to forward it to other students.
