- We get about 2 a year
- So I don't know if this will happen again.

Approval to utilize up to \$8000 from the ASNC Reserves to purchase sewn-in lines for rugby" on the Norco College Soccer Field.

- We have half a million dollars in the reserve and we use it to improve student life, like the vans, this is a chance to help out sports.
