The committee/council is satisfied with the defined composition of the committee. There has been an issue for the past year in which a Department Chair from BEIT could not be found from within the department.

Fortunately Colleen Molko, and filled this position, but Colleen is not faculty (she is a Dean) and this has put her and the committee in a few awkward situations including her not being a voting member of the committee but still needing to successfully representing Gaming/CTE. This problem will persist into next year as none of the faculty from that area are willing to step up to serve. The administration is currently exploring ways to remedy this situation through the possible outside hire of a Chair to serve.

- *The APC has worked diligently with the scheduling grid to reduce the number of conflicts for students. This has been measured via the number of overlapping class petitions filed with the Dean of Instruction's office.*
- *The committee has developed 5-year rotations for all degree patterns.*
- *The committee is working closely with administration and constituent groups on the Completion Initiative aimed at improving student matriculation.*
- *The committee has committed to convene to work during the 2016-2017 academic year to overhaul the entire schedule in an attempt to improve the flow for students. This would be unveiled for the Fall 2017 semester.*

Goal 4: Create Effective Community Partnerships

Objective 2: Increase the number of industry partners who participate in industry advisory council activities.

Norco College Career & Technical Education (CTE) hosts an annual Industry & Advisory Breakfast during the spring semester. The goal of the breakfast is to invite our local industry, community, and educational partners to meet with Norco College faculty to review curriculum and offer needed input into what industry expects from our students.

The event has also become an opportunity for the College to promote current programs, events, accomplishments, as well as provide our faculty an opportunity to collaborate with industry and other educational partners.

Past Attendance:

- *2015-2016: **85** Industry Partners, **163** Total Attendance (Community, High school district partners, & Norco College attendees)*
- *2014 – 2015: **70** Industry Partners, **115** Total Attendance*
- *2013 – 2014: **75** Industry Partners, **108** Total Attendance*
- *2012 – 2013: **64** Industry Partners, **101** Total Attendance*

Though the number of Industry Partners attending has remained a steady increase, we have also been able to build the number of industry partners in each advisory group. Each year new partners attend, and others may miss the current year's event but remain on our roster.

For many years, the event was held off campus due to adequate space. But the event has been held on the Norco College campus the last three years (under a large rented tent in the amphitheater). This has allowed faculty to provide our attendees with a firsthand view of our campus, classrooms, technology,

and in some cases, a demo provided by students.

Objective 4: (together with ASNC) Increase institutional awareness of partnership, internships, and job opportunities established with business and industry.

In 2011, Career & Technical Education used Carl D. Perkins grant funds to hire an Employment Placement Coordinator. In this role, Ashley Etchison has assisted with placing students directly into internships and jobs, as well as other related duties.

Through activities such as attending local Chamber of Commerce meetings, planning and hosting Career & Job Fairs, cold calls, marketing, referrals and other employer-related activities, the placement rate has consistently increased:

- 2014 - 2015: **75** Students were placed directly into internships and employment
- 2013 - 2014: **72** Students were placed directly into internships and employment
- 2012 - 2013: **53** Students were placed directly into internships and employment
- 2011 - 2012: **40** Students were placed directly into internships and employment
- 2010 - 2011: **15** Students were placed directly into internships and employment

Integral to job placement is also marketing to students and making them aware these opportunities are available to them. We currently have more available jobs than students to fill them! Attending classes to present job opportunities and gain contact information of students has been helpful, as well as faculty referrals. Sending targeted email blasts to students that have completed specific courses/programs has also been an important strategy.

Mrs. Etchison is no longer in this role. We have no dedicated staff to focus on this strategic goal going forward.

- *The use of data has become the center of everything APC does. This is evidenced by the consistent use of data in Faculty Position Ranking and enrollment management (e.g. scheduling)*
- *It's worth noting that Norco College has not missed an enrollment target in more than 3 years, even while other colleges in the District are failing to make their goals.*

It has been noted that the monthly committee meeting coincides with the weekly ASNC meeting. However, there should be at least 1 student representative on the DE Committee (even if the student is not an ASNC member). A student should be on the DE Committee due to the shared governance process. Also, having student representation on the DE committee would allow the student voice to be heard to address issues and concerns about the DE learning environment at Norco College.

According to a report from Norco College's Office of Institutional Research, this goal has been met. The success gap between DE & face-2-face students is decreasing. The committee is currently investigating measures that were implemented in the last 2 years that may have resulted in the decrease.

The committee is currently working with the Assessment Committee in order to find out which DE courses have been assessed across disciplines. The committee will also need information from instructors who have assessed both their face-to-face and DE courses in order to determine whether or not this objective is being met. This will be an ongoing project that will require the DE committee to coordinate with both the Assessment Committee and Office of Institutional Research at Norco College.

The committee plans to obtain disaggregated data of course-level assessment by instructional modality (F2F vs DE) and establish a formal liaison with the Assessment Committee (the Administrative Co-Chair) and Technology Committee (Walter Stevens). This will allow the Committee to define what steps need to be taken to meet this goal.

The committee would like to continue to make sure that any new members of NAC are aware that it is an active committee, meaning that each member will at some point be engaged in work/activities to support the committee. This might come in the form of guiding department members in assessment, using TracDat, or reporting in

department meetings on NAC activities. In addition, all NAC members must participate in scoring the assessment section of the APR and CPR. Ultimately NAC is a committee that needs to be comprised of faculty members that understand assessment, are conducting assessment, are familiar with TracDat, and that have written Annual and Comprehensive Program Reviews. We are a purpose driven committee and members will be expected to engage. When a new member of the faculty joins NAC we plan on setting up a mentoring relationship with an existing member to help with the steep learning curve of the committee.

SLO assessments in the fall were completed at a dismal 50% rate. Many courses subsequently remain unassessed and will roll over to the next semester in which they will be offered. Many of these unassessed courses are taught by full time faculty that are required to participate equally in assessment (per the contract). Only 1 Program Assessment out of 14 were input into TracDat. I know of only 1 other that has been completed. This lowered our success rate from 100% in the fall 2015 to 75% in the spring. The Program Level assessment is a really big red flag for ACCJC.

We might not all like or agree with doing assessment, but it is now part of our current job – any help you can give would be appreciated.

A charge to all faculty to engage in assessment to help us avoid being put on Warning or given a Special Report. At this point

Program Review Committee Year End Statement

This year the Program Review Committee did the following things:

- Revised the templates for both Annual and Comprehensive
- Revised the rubrics for both Annual and Comprehensive
- Continued to work on linking Program review to the strategic planning of this college
- Attempted to restructure/dissolve the District level program review
- Asked the Departments to consider what makes sense to them in terms of program/discipline review in terms of groupings and stand-alone disciplines.
- Will have scored all program reviews submitted before the end of the term.

Our Plans for next year:

- Consider the viability of having all program reviews completed in TracDat to avoid the unforeseen problem this year of the lengthy document. Breaking the data down by demographic information changed the chart from 3 to 36 and this expanded the document size. The same is true for including a printed copy of assessment at the end of the document. Some program reviews were over 100 pages.
- Based on the discussions the Departments will have mentioned above, we expect to restructure who completes a program review and we are discussing the frequency of review as well. We will require department input as this is not a decision that can be made unilaterally. It must meet department needs and vision. It must also meet the ACCJC requirements which are being considered within the restructuring.

District level issues:

The MVC representative is retiring. RCC is electing their representative and it may not be the same representative as has previously served. If that is the case, while we normally rotate the chairship, it may not make sense to pass the chair on to someone who has never served on the committee before, particularly in light of the loss of administrative support for the meetings (we will have no secretarial or district manager). If the committee is not dissolved, AND RCC elects a new PRC chair, Norco should retain the chairship. If the committee is not dissolved, the Academic Senate needs to provide a charge for the district committee as the process of accepting or rejecting Comprehensive Program Reviews makes little sense except for the handful of disciplines that complete a joint comprehensive (those need to be identified as much has changed). In short, Norco believes the committee should dissolve as it no longer serves its charge or the purpose statement of the committee. If it is to continue, the DAS must give us clear instruction of what work it would like done on its behalf.
