- A. <u>BPAP 3950</u> Naming of Facilities, Events, and Programs-First Read (Campo) Updated version of the board policy and administrative procedure has been brought forward from RCCAS for consideration.
  - First reading of the BPAP 3950 Naming of Facilities, Events and Program
  - RCC Academic Senate already approved it and Moreno Valley will be presenting the BPAP today
  - P. Campo requested faculty to please review the policy and bring any comments on the next meeting
  - Item II in the policy was highlighted. This section states the committee will be comprised of one member of the faculty from each college in the District, as determine by the college President in consultation with the Academic Senate

- C. <u>Norco College Professional Development Plan</u> (Draft)-Discussion item- (Bemiller, Molko, Reade, Russell, Zamiska)

The Norco College Leading from the Middle team will be presenting the Professional Development plan for feedback.

- Q. Bemiller presented a Leading from the Middle Professional Development Plan for Norco College in support of Guided Pathways that included the following items:
  - Funding for a full time coordinator for professional development for faculty and staff. It can be a staff position
  - O Disaggregated data should be more fully transmitted to all staff and faculty. Institutional support and training to interpret and use data must be provided
  - o Equity based pedagogy training and support for all faculty and staff
  - Align professional development activities for faculty, counselors, and staff with the four Pillars and guided pathways
  - o Increased support for part-time (associate) faculty. Having a mentoring program and making training more accessible to faculty
  - Professional development for leadership roles and career advancement. Norco College needs to take responsibility
  - o Training and ongoing support for faculty and staff advising. As an example: Have a faculty advisor liaison for each of our schools
  - Implementation of staff specific professional development activities. Mt. Sac has a
    professional development counsel, professional development committee for staff and one for
    faculty. It would be good for the classified senate to form a sub-committee
  - Update college and committee websites. This includes updating the website and using CANVAS
  - Professional development committee organization changes. This includes funding for an
    annual budget for conferences. They are also putting together a procedure which includes the
    type of funding on the requests and a central place for faculty to submit their request. In the
    meantime, certain items can be included in program review
- Quinton provided a Norco College Annual Professional Development Budget in Support of Guided Pathways handout
- Geovanni Sosa is assisting Norco College to apply for the innovation grant. This should be presented on the student success committee
- O. Bemiller indicated to please feel free to send any suggestions to any members of the group
- D. Military Articulation Platform-Information item (Campos, Harmon, Lee)
  Samuel Lee, Pedro Campos, and Lorenzo Harmon will present information on Norco College's Military Articulation Platform to provide veterans educational credit for prior learning experience.
  - The goal is to work with about 3,000 veterans that find it difficult to transition from military life to attending college
  - Articulation platform is utilized to grant credit to veterans who take courses at the college
  - There are approximately 25,000 military courses that can be articulated with our courses
  - The courses will be approved by faculty

- A brief instruction to the system was presented to the academic senate members
- In order for courses to be articulated they need to have an 80% passing grade
- ACE recommendations are used for each course description. The recommendations are based on the skill level, rank and hours of training
- Faculty member can make a recommendation or add another course when approving a course
- A faculty member only approves the course once
- The platform is in the development stage and it needs faculty feedback. A new workgroup or a special project can be approved for faculty that would like to participate in the development of the military platform
- These articulations are not granted until they apply for a degree or graduation
- About 40,000 veterans are getting discharge in California
- A data base of veteran's outreach will be built in the military platform
- The AB 1786 bill was signed by the governor for community colleges to have some kind of system to provide course credit to veterans
- A team from Norco College presented the articulation military platform at the Senate Plenary on Friday November 2<sup>nd</sup>
- Motion to extend the meeting for 15 minutes; Kimberly Bell moves; Kim Kamerin 2<sup>nd</sup>, motion passed (No abstentions)
- Pedro Campos program developer and CEO of ITPI has put together programs of study information from the course catalog. They hope to integrate this with COCI. There is a section for feedback to keep improving the system
- K. Fleming and P. Campos will be presenting the military platform in the Community College League of California Conferences next week
- It was mentioned that by approving a single semester, veterans can saved over one billion dollars a year in education
