#### VII. Proposed Changes to Norco College Academic Senate Constitution (V. Lee)

#### **Constitution: Article III, Section 3**

- i. Proposal to create two categories of membership
  - a. Voting members

b. Non-Voting

## **Constitution: Article III, Section 4**

- i. Proposal to limit the terms of office for Senate Officers to two consecutive, three-year terms
  - a. The proposal would allow for an Officer to return to her/his office after sitting out a term.

## **Constitution: Article III, Section 6**

- i. Proposal to define a quorum for meetings of the Academic Senate as a majority of voting members.
  - a. The proposal is contingent upon the membership categories being broken into the categories of voting members and non-voting members.

# **Constitution: Article III, Section 7**

- i. Proposal to redefine a quorum for Senate meetings as a majority of voting members.
- a. The proposal is contingent upon the membership categories being broken into the categories of voting members and non-voting members.
- ii. Proposal to redefine a quorum for faculty meetings as one-third of "full-time faculty" instead of just "faculty."

## **Constitution: Article V, Section 2**

i. Proposal to allow all faculty members the right to vote for Officers instead of only full-time faculty.

Not Approved: M/Muto, S/Hicks: 3 oppositions: M. Bobo, B. Johnson, K. Kamerin, 1 abstention

- ii. Proposal to change the process by which the Academic Senate fills vacancies in an elected Officers position
  - a. The current process involves a vacancy being filled for the remainder of the term by a majority vote of the Academic Senate.
  - b. The proposed new process involves a vacancy being filled for the remainder of the year by a majority vote of the Academic Senate and then holding a special election to fill the position if more time remains in the term.
