The Associated Students will discuss and vote to fund \$1,200 for the CSEW event, specifically for snacks and Jersey Mike's lunches.

Event Details:

- Date and Time: May 21st, from 11:00 am to 12:30 pm.
- Activities include kickball and lunch with students and staff.
- Location: CSS Grass, due to issues with accessibility and attendance at the soccer field.
 - It is the second event of this nature to be hosted.

Safety Concerns:

- Rafael raises concerns about safety due to the high-traffic location.
- Aneesa notes that the previous event was safe, implying that issues are unlikely.

Event Logistics:

- Flyers and tickets will be used to promote the kickball event.
- Safety measures include putting up markers to advise others in the area about the ongoing event.

Location Discussion:

- Yusuf asks about the possibility of hosting the event at the soccer field.
- He was told it is impractical due to issues as the soccer field needs their field, and if it is hosted there, accessibility and attendance concerns may arise.

The Associated Students of Norco College will discuss and vote to create an ad-hoc committee to identify methods for obtaining food on campus that is equal quality as off-campus options at a competitive price.

Presentation Highlights:

- Chef presents numerous factors affecting food prices on campus, including inflation, increased facility costs, and the procurement process for obtaining food.
- New vendors have been obtained to offer more food variety, but inflation has caused a rise in food prices.
- Additional facility costs, such as machine replacements and repairs, contribute to the overall expenses.

Discussion Points:

- The committee will aim to alleviate pressure on Chef by assisting with financial decisions.

- There is a consensus that the committee should focus on helping students as a whole, not just through the Corral.
- Representatives from ASNC, Basic Needs, and other clubs facing equity issues will be included in the committee.
 - Appointees for the committee will go through executives, ensuring proper selection.

Committee Structure:

- The committee will work with Chef on pricing and financial matters related to the Corral.
- It will be student-run and comprise of campus-shared governance with representatives from equity organizations.
