We are seeking the input and support from the student representatives of Norco College.

The Associated Students of Norco College shall discuss and vote to approve the ASNC budget for the 2023-2024 fiscal year.

Edwin: Student fees cover our budget. Student enrollments say that our budget should be \$700,000. 1 in 3 students are not paying this fee which means this number is inaccurate. Next year's budget will be lower. I recommend you wait until June 2nd to approve this budget so that time can be invested in solving issues that might arise, to hear out from various groups. You all have the right to take money from one line item and put it into another line item. The total budget will still not go up overall.

Justin: The proposed budget for Rugby next year, is the total because they intend to ask for the SCRUM machine out of this year's budget?

Edwin: No.

Aneesa: The SCRUM Machine was communicated to me as more of a want than a need. It would be nice but is not needed for Men's Rugby to succeed. The district has not even given us a concrete number.
