# Sen.10.07.01 Approval of \$2,245 from ASNC contingency line item 5219 for the cost to take two students to the 2019 student veterans of American Conference.

## Motion Author: Jose Castaneda (Action Item)

The Associated students of Norco College will discuss approval of \$2,245 dollars for two students. Money will cover conference ticket, meals at conference, hotel room and plan ticket.

Motioned by Aimee, Seconded by MK

Jose: Student Veterans of America is the organization who came up with the GI bill. They also were responsible for fighting for the STEM program. The conference is a chance for veterans to meet other veterans as well as other organizations. The cost covers the plane ticket as well as the hotel. The trip will be a school trip. Conference is from January 3-5.

Raiann: Why not use the \$10,000 you have left?
