Motion: Sarah Second: Rudy Dr.Gustavo: Thank you everyone for coming. We are developing many plans such as Educational Master Plan. We are also developing the Student Equity Plan. I want four of you to join me to be a part of the work group to get your insight since this is specifically for students. Equity is giving more resources for those who need it to be at the same level with everyone else. We are required to look at groups such as students with disabilities, and foster youth, etc. We have to look at students who had access, retention, and completion of courses, certificate completion and then transfer. The plan requires ethnic races to be at the 80% rule of success, but if not, they are considered to be not doing well.
