Sen.02.24.01 Update from the Dean of Student Life Motion Author: Dr. Mark Hartley (Discussion)

The Dean of Student Life will update the Associated Students of Norco College regarding funding requests and goals for the Spring 2021 Semester.

Dr. Mark Hartley: Dean of Student Life, oversees all the fun and athletics. ASNC and student conduct falls under that as well. Also oversees commencement. Thank you, guys, for what you are doing, and I need you guys to know that it has made a difference. We've help feed students that would not eat and give students a place to stay and helping them stay in school. Truth of the matter is that college education matters. Education matters a lot to people who need help financially. ASNC donated \$5,000 to the student life emergency funds and created a new plaque level. The money is also being used for textbook scholarships and textbook grants. The money is being put to good use and helping a lot of students. Tears are flowing in a positive way. Three years ago, we spoke about a shade structure for commencement and be a study space for students. If ASNC contributed to the funds, that would cover about one third of the cost for the amphitheater. During the meeting it was mentioned that ASNC did not give the funds because it was covered by another source of funds. What can we place during that meeting? 50% of the CARES Act is directly for students and the other 50% is supposed to be used for the campus for when students come back. Also, finish strong this semester. Some of you are graduating and transferring and some of you will be coming back, you need to finish strong. Part of finishing strong is leaving your legacy.

The Associated Students of Norco College will receive an update from Bruce Twersky, President of App Builder U and the College Discount Cards, regarding the ASNC Discount Card Program.

Bruce Twersky: I was on campus last year and located on the second floor. We had an email go out, but we wanted hard copies. Then we moved to apps and now we are going to a digital format. There are a ton of free deals you can access when you download the app. There are a lot of local deals along with electronic deals. Then you can look at the app along with the colleges that are on the app and you can see the local discounts around there. What I am presenting to you today, that we are offering for Moreno Valley, Norco & RCC is that we can get our own app with all our own information along with the discounts. Features include agendas, push notifications, calendars and ASG directory. It will have national and local brands. Pricing is \$4,995 as a build out and \$495 is the monthly hosting. Total investment comes out to \$10,935 but it comes with a credit of \$4,000. Every year going forward you just pay the monthly hosting. This would also be a three year agreement.
