Sen.03.04.01 Approval of up to \$7,000 from Transportation Fee (92133) to purchase a three-year agreement for an ASNC App.

The Associated Students of Norco College will consider approval of the purchase of an ASNC App, three-year agreement, presented by Bruce Twersky, President of App Builder U and the College Discount Cards.

Edwin Romero: We went over this last meeting. I can share the invoice to show the details. Three-year agreement. We would be paying for the design, app developer, etc. All the content is owned by ASNC/RCCD. We still must keep our website to be up to date so that our app to be up to date. Since we already have the discount cards, we got a credit that we are about to use towards our total. The balance we would be paying is \$6,935.

Anisha Solhotra: It is a good idea but there was another app that we had on campus called something guru. The app glitched a lot and was sending out way too many notifications. When we promote stuff on campus it gets around pretty fast but the only thing I am worried about it if it glitches or is slow because I know students will mute the whole app or delete it.

Edwin Romero: We have to do the three-year deal because that is what the district suggested, or it was what they said. Bruce wanted to do year to year so that we would be able to see if we liked the app or not. GradGuru was just a push notification app, but our app would have discounts which would be an incentive to download the app. We can limit the push notifications so that students will not be annoyed. We would be paying about \$200 a month so we should shoot for at least 200 students to download and use the app. If the company did not fulfill the details in the contract, we would be able to breach out of contract.
