Sen.04.29.01 Bill 1: ASNC President Candidate Qualifications Motion Author: Angelica Calderon (Discussion/Action)

The Associated Students of Norco College will approve amendments to the ASNC Bylaws to expand the eligible candidates for ASNC President.
