- Not all the changes were made to the budget's line items. We will be looking at the entire athletic budget to approve. Makenna Ashcraft motions to increase the Men's Soccer (92601) from \$10,000 to \$15,000. Seconded by Aracely Bello

- Motioned by Makenna Ashcraft to increase the Women's Soccer budget (92613) from \$10,000 to \$15,000

VII. ASNC Advisor Report

- Romero had a meeting with the budget officer and discussed with the officers about why the budget is extremely high and he agrees that it is high, but sustainable.
- Will be thinking about long-term plans as our budgets have doubled and is looking for support
- Is looking to schedule counseling, training, and mentoring for the next year, but is extremely busy with requisitions, which he does not believe is his job.
- Mustang statue is going to be extremely expensive to put up in the Mustang circle due to traffic areas and suggests that we do it in the center of campus. The circle would make it about \$100,000 more
- Reminds that ASNC will be inactive during the summer. Dr. Hartley will be discussing with us about summer hours
- Asks for volunteers for commencement next week.
- Reminds us to pick up Disneyland tickets and shares that there is a growing waitlist of students who want to go to Disneyland. Monday is the deadline to pick them up.
