Sen.10.07.01 Approval of up to \$1,200 from Executive Contingencies (92199) for Gaming Social Club's

The Associated Students of Norco College shall discuss and vote on funding a gaming console, storage cabinet, and related social gaming equipment, to be stored in the STEM Building for the use of student clubs.
