Cheryl: Complaints were made about finances not being made or were given late.

Eddie:" Commitment issues have not been an issue for me," nothing was said about him where he has Not missing the meeting and attending the events, tardies are due to legal troubles.

Haroun: ASNC should be a priority. However legal issues come first. If dealing with legal issues, then ASNC should be placed on hold till further times

Eddie: Pushbacks on the probation office, but sometimes cannot push back. Wants to continue ASNC.

Juliett: Attendance policy has "not been fully violated". What other violations have been present?

Adel: address article 14- inappropriate conduct. Racist remarks have been made towards Danny. Eddie: Claims hardly in ASNC and MOC office. Claims the first violation is false.

Danny: Eddie may have not been at the office much the few there has been a major issue, Adel made mistake

Was made regarding Danny's ethnicity about being Jewish, Eddie exclaimed "Gas the Jews." Eddie Mentioned that he has not been at school for weeks, and his grade in Spanish is less than 20 percent Grade average is not worthy of being an ASNC member

Cheryl: Dr. Romero received grades and had ASNC exceptional grades.

Eddie: Have not missed 4 weeks of school. Could not afford textbooks, so could not do the assignments which dropped his GPA. Working with the counselor to raise GPA. Does not recall making a

racist joke about Jews.

Dilraj: Who was present when the joke was made?

3 total witnesses of the incident.

Hassan: Eddie mentioned Hitler and mentioned something along the lines of "gas the Jews".

Danny: Eddie said "How Hitler gassed the Jews"

Adel: Danny's grandfather was German, which is how the conversation sparked. After the comment was made about Danny being part Jewish, the comment was made by Eddie.

Eddie: Now recalls repeating a joke, stating Adekand Danny were talking, and a student made the He has an uncle who served in the war and does not like making jokes.

Yusuf: Heard what the other three witnesses heard. Accountability needs to be made. What was said was offensive to Danny.

Danny: 4 witnesses have all said the same story against what Eddie had said.

Eddie: In the beginning, he does not recall saying the joke. The person said "Hail Hitler, gas all the jews". Eddie laughed at the joke. Someone asked him what was funny, so he repeated the joke out loud.

Dilraj: Regardless of the phrasing or someone said it, he thinks Eddie is at fault and admitted to Laughing to the joke. Dilraj was asleep.

Eddie: The comment was made by someone who is not part of ASNC. The person who made the joke was Marcos. Marcos was on the left and Dilraj was on the left.

Adel: Friday was the day the comment was madeh Marcos worked during that time, which was when a comment was made.

Hassan: Also did not recount Marcos being present.

Haroun: Lack of consistency in the story and lack of accountability.

Eddie:" Recall every single detail." "It's hard to remember when a joke is made."

Yusuf: Accountability needs to be upheld. What needs to be expressed is "I do not recall this happening, but I apologize", instead of trying to explain and trying to defend himself.

Danny: He's continent knowing that Eddie is doing great in school, but wants to address not recalling Information and now getting new non relevant information about this instance. Four people testified. All the stories and details made by the witness have been consistent. There is no continuity in Eddie's Stories.

Eddie:" I have a good memory." Talks about his games coaches, and friends who are wearing the s

Pants and he's going to remember his memory.

Isaiah: Work on non-ASNC members utilizing the office when it is only made for ASNC members. Eddie: Event for Article 14, The event happened a few weeks ago. Wonder why the event was not brought up the day of, instead was mentioned several weeks later.

Haroun: Tried communicating but ghosted, it was swept under the rug until Danny and Eddie started Working together

.Dilraj: Eddie brought friends into the ASNC office, which was an issue.

Yusuf: In terms of Eddie bringing his friends into the office, Marcos was in the office as well. Eddie: He realized how many people were in Mache had left them a note stating that they should In the office space, he did not know they were there

Adel: issues have been made regarding hostility. An issue arose because of a jersey. Eddie: Claims not to care about sports, and hearsay information.

Juliett: Address the fact that it is not personal. Apologizes to ASNC for his issues. Personal I issues should be taken into account when it comes to ASNC. ASNC should be here to support the community no matter what they are going through and ASNC should have leniency with personal Issues. Article 14 should be the main focus becather there are many witnesses who can comment on remarks that were made.

Yusuf: Consider how the vote will affect and better ASNC.

Parisa: if Eddie takes accountability and addresses what was said, the situation could be better. Eddie: states that he apologized to Danny. He claims he and Danny were campus friends and apologized. Before trying to defend himself, apologized to Danny.

Yusuf: An apology was made, however, him defending himself could lead to the apology being

washed out.

Danny: Accepts his apology and hopes he recognizes his faults.
Yusuf: Address any issues with the person, Dr. Romero, or Yusuf.
Vote: 8 in favor. 1 not in favor: Eddie. 6 abstain: Parisa, Juliette, Brooklyn, Hassan, Isaiah,
