Accreditation (ACCJC)- accreditor for two-year colleges. Provides standards and reports that line with their standards,

ACCJC focuses on the improvement of the college and how to better support students.

Comprehensive review process- self-evaluation, peer review, and commission review.

Facilities from other colleges come to campuses and review to decide if they get accreditation.

In terms of preparation we are on time and earlier; communicating with the peers and constitutions

the self-evaluation portion started in spring through the fall written review; the commission decision will be next.

August 1st, 2026, takes time to write the form making sure everyone is aware of the process

Norco Timeline addresses the activities done prior to the submission of the report accreditation is important to reflect on how to improve how we serve students and share how we improved to prompt Norco College.

Money for travel, lodging, and food  
Campgrounds in Idyllwild, 35 club members composed of choir class students, expected the same amount of admissions for the spring  
per person: 176 and they have 35 so 6160 extra 340 is for any unexpected enrollment  
the purpose: Strengthen new bounds and promote new admissions  
Staying in Emerson Hall campgrounds.  
Campgrounds staff provide meals.  
Had a previous retreat costing \$4,700.  
Paying for campgrounds and means- no official breakdown of the \$176 per person.  
Proposing to get an official headcount to ensure a proper amount of funds is granted.  
Funds do not reset, they can come back when the head count comes back in because it is unpredictable  
40 is max for registration of the class, the limit should be kept at 35 for the previous enrollment  
Finding cheaper alternatives for the retreat mainly because other clubs have not had the opportunity to do a retreat  
Other classes will be asking for the same offers in a continuous semester.  
Budget needs to be reevaluated.
