Senate 04.25.01 Events and Catering Procedures

Motion Author: Cameron Young

(Discussion Item)

The Associated Students of Norco College will discuss a letter that will be presented to the Academic Senate and Resources Council regarding events and catering on campus, and provide feedback.

Motion: Lien Second: Danny

Young: Discuss the sudden date of student fees, and the students' choices are not being met. Historically, since 2014, the rule was never been enforced. When the cost increases, it will lead to a decrease in the students' voices.

Reached out to numerous advisors' clubs. The Academic Senate was held in order to end this dilemma. Feedback would be very helpful to demonstrate the real-world impact of this mandated policy.

The mandate would be placed to remove ASNC from this mandate. The best compromise that can be seen.

The cost of Corral food is much higher than what can be found at outside places.

High prices make the asking price for clubs very high.

If we want food from outside catering, we need to justify that with the Corral food prices. Essentially, compare and contrast the prices.

ASNC being a student body means that the board will be more likely to listen to ASNC's voices.

"We have to be loud for change."

"Corral has the first right of refusal" is not on the board policy; it is an interpretation of the board policy. This mandate is only being mandated at Norco College.

Faculty has been difficult to get on board due to "an error of fear".

Events have been pushed back because of the mandate, and the increase in funds has also added to the push back and withdrawal of many of the events planned.

Gabriel Graves: The cafeteria at RCC does not have a manager to cater to any food requests. If RCC wanted food from somewhere else, it is not a mandate. Seize and assist with the clubs regarding catering.

World of Women hosted an event for women, but the Chief said he couldn't cater.

Fashion for Change wanted Jumbala, but the Chief said he could also cater, even though the authenticity was greatly diminished.

Gabriel Graves to potentially get ASRCC to present on the issues of the food policies being pushed onto Norco College to make them aware of what is happening and prevent further push of these policies.

Remove ASNC as a requirement or mandate to give funds for clubs to cover the prices of food.

Communication with the Chief is lacking, the snacks that were supposed to be delivered and there was a misconception that they did not arrive, and the distribution of promised goods were not delivered to satisfaction.

Student clubs are required. However, outside events such as the chancellor's events are not required to go through the Chief.
