- 1. On the CurrIQUnet Maverick website, there is a message about launch deadlines for the 26/27 catalog. More discussion about the launch dates and to make sure faculty are ready since there will be 13 courses in Phase 2A.
  - Common Course Numbering Courses: September 19, 2025.
  - CCN Approval Deadline for Facilitators and Chairs: September 26, 2025
  - All other Proposals (Courses and Programs): October 3, 2025
  - Approval Deadlines for Facilitators and Chairs: October 10, 2025.

- 2. Creative Collaboration Now: Common Course Numbering Updates PowerPoint attachment. Also listed on Curriculum committee website under 'Link to State Resources'. Phase 2A are 13 courses. AHS-1, AHS-2/2H, ECO-7/7H, ECO-8/8H, ENGL-1B/1BH, HIS-6/6H, HIS-7/7H. September 19<sup>th</sup> the CCN numbers to these courses need to be launched in CurriQuNet.

- 4. WKX- Work Experience Courses Brian Johnson discussed what District Curriculum Committee (DCC) that Casandra Greene and Kelly Douglass are working on. Work experience courses are out of compliance. Casandra spoke with faculty at RIV and recommended making a single course for common discipline areas, such as AUB, AUT, EST, AIR, and WEL. The course would have a cross-discipline so any faculty from the area can teach it. The hope is this would reduce the number of work experience courses and help fill them. The course needs to be revised to align with the 54 credit-hour calculation with 1 to 14 variable units. They also need to determine who owns the WKX course. To see which college uses the WKX course more frequently. The Norco Curriculum committee discussed their reasons why they want to keep specific discipline WKX courses and asked Brian Johnson to ask DCC how to handle the low enrollment WKC discipline specific courses.
- 5. Survey of Effectiveness Results Brian Johnson went over the results from the survey and committee agreed for Brian Johnson to complete the final form to submit.
- 6. Discipline Origination Permissions. Bryan Medina will begin putting together a list to be reviewed by the committee of remaining faculty, their origination permissions, and identifying which permissions should be removed.

## Why Common Course Numbering?

- Credit mobility and equitable baccalaureate attainment
- Current course numbering varies. Articulation processes are cumbersome. Results vary by college.
- Students deserve to have consistent information when choosing and articulating course work
- It is the law: <u>Education Code 66275</u>, amended by AB 1111 (2021, Berman)
  - "(a) (1) To streamline transfer from two- to four-year postsecondary educational institutions and reduce excess credit accumulation, on or before July 1, 2027, both of the following shall occur:
    - (A) The California Community Colleges shall adopt a common course numbering system for all general education requirement courses and transfer pathway courses.
    - (B) Each community college campus shall incorporate common course numbers from the adopted common course numbering system in its catalog.
    - (2) The common course numbering system shall be student facing...and ensure that comparable courses across all community colleges have the same course number."





### Background and Vision

- AB 1111 Common Course Numbering Task Force (Sept. 2022 Dec. 2023)
  - Intersegmental and cross-function membership
  - Report and Recommendations (2023)
- Common Course Numbering Project
  - Task: Implement recommendations from Task Force
  - Plan to use a phased approach for development of templates and student-facing implementation
- Vision of system-level articulation from community colleges to universities using CCN Course Templates for:
  - Common transferability from all CCCs
  - Common General Education applicability from all CCCs
  - Consistent course-to-course articulation from all CCCs
  - Potential for more consistent major prep articulation

### **CCN** Implementation Updates

### Phases include 3 parts:

- Development by intersegmental faculty of CCN templates for each phase
- Local curriculum revision to incorporate template info into CORs; submission to COCI and ASSIST
- CSU, UC, and independent college and university review updated CORs for transferability, general education, and articulation





### Phase I Updates

- 14 templates developed to be implemented Fall 2025
  - 6 highest enrolled courses
  - 8 honors versions, plus 2 embedded support versions
- Colleges submitted to COCI and ASSIST in December
  - Awaiting UC, CSU, independent review for Cal-GETC, course-to-course articulation
- Local preparations for student-facing implementation
  - Curriculum revisions: CORs, programs, pre-requisites, etc
  - Technology system impacts
  - Student-facing: catalogs, schedules, transcripts, communications, faculty syllabi
  - Communicating to students about changes





### Phase II Updates

- 23 total courses
  - 8 templates released March 2025 for implementation by Fall 2026
  - 15 templates being finalized for implementation by Fall 2027
    - Additional post-development survey opportunity open now
    - Release by Chancellor's Office by early June
- Colleges are beginning COR review and revision processes
- Articulation
  - Submit to COCI at any point; no deadline like with Phase I
  - Submit updated CORs for UC transferability in Summer 2026
  - Submit for Cal-GETC in December 2025





### Phase III Updates

- Templates to be developed for 47 courses
  - Intersegmental discipline workgroup (CCNFW) convenings in June
  - Pre-survey period closed 4/15; post-survey period to be held late summer/early fall term with CCNFWs re-convening in October
  - Templates to Chancellor's Office in December; CO public release to follow
  - Phase III courses to be implemented by Fall 2027

#### CCNFWs

 18 workgroups, each w/ 12 CCC faculty and up to 6 total UC, CSU, and independent college and university faculty





### **Articulation Updates**

- Conversations about the CCN articulation vision are on-going with UC and CSU
- Segment updates:
  - UC
    - Campuses have access to CCN templates from Phase I and available Phase II templates
    - Campuses may consider adopting a two-year phase out in instances of course-to-course articulation denials
    - UC TCA submission for Phase I CCN-aligned CORs postponed due summer 2025
    - UC TCA submission for Phase II CCN-aligned CORs postponed due summer 2026
  - CSU
    - Campuses have been asked, and have agreed, to review the templates for course-tocourse articulation for Phase I





### Next Steps

- CCN Council discussing "tipping point": when will we have enough CCNs?
- Early planning for Phases IV+ template development
- Awaiting CSU, UC articulation feedback for Phase I courses to determine what, if any, revisions are needed to templates
- Early planning for state-level template review and update cycles
- Advocacy for funding
  - On-going to continue implementation and sustain curriculum currency (all segments)
  - Dedicated ASSIST funding





### Local Actions

- As needed, help students and colleagues understand why some course numbers are different and what the intent of the project is
- Converse with department colleagues about curriculum revisions, including Part 2 of CCN elements
- Update course documents with new course numbers and titles
- Continue to provide faculty input to ASCCC CCN course surveys: pretemplate development and post-template development feedback is vital!






## Q1 Please rate your level of agreement with the following statements for the governance entity selected above:




