- a. Area Updates
  - i. Hire of a FT tenure-track EOPS/CARE/NextUp counselor (posting soon)
    - 1. Also hiring-EOPS/CARE Specialist, planning for onboarding by Aug2024
  - ii. EOPS Services to CRC-pilot in Sp24/full integration F24
    - 1. Will develop a modified MRC for this population (review in Fall 24)
    - 2. Kramer-has made connections with currents students in the Prison Partnership program. Providing more contact and support with a small pilot group
  - iii. Student Resource Specialist supporting foster youth-posting position starts mid June 24
    - 1.
  - iv. Proposed revisions to EOPS Title V regs
    - All new and continuing students must apply for FAFSA annually to remain eligible

       Removing caps for grants and work study
    - 2. Within 2 months in program, must provide income documentation
      - a. CARE students only
    - 3. Remove unnecessary admin burdens and increase flexibility for colleges to engage in local decisions to implement evidence based practices for equitable outcomes
      - a. BlackHawk is a vendor which provided universal grocery and gas cards
    - 4. Eliminate outdated fixed dollar amount caps for EOPS grants and work study awards-base it on unmet need.
