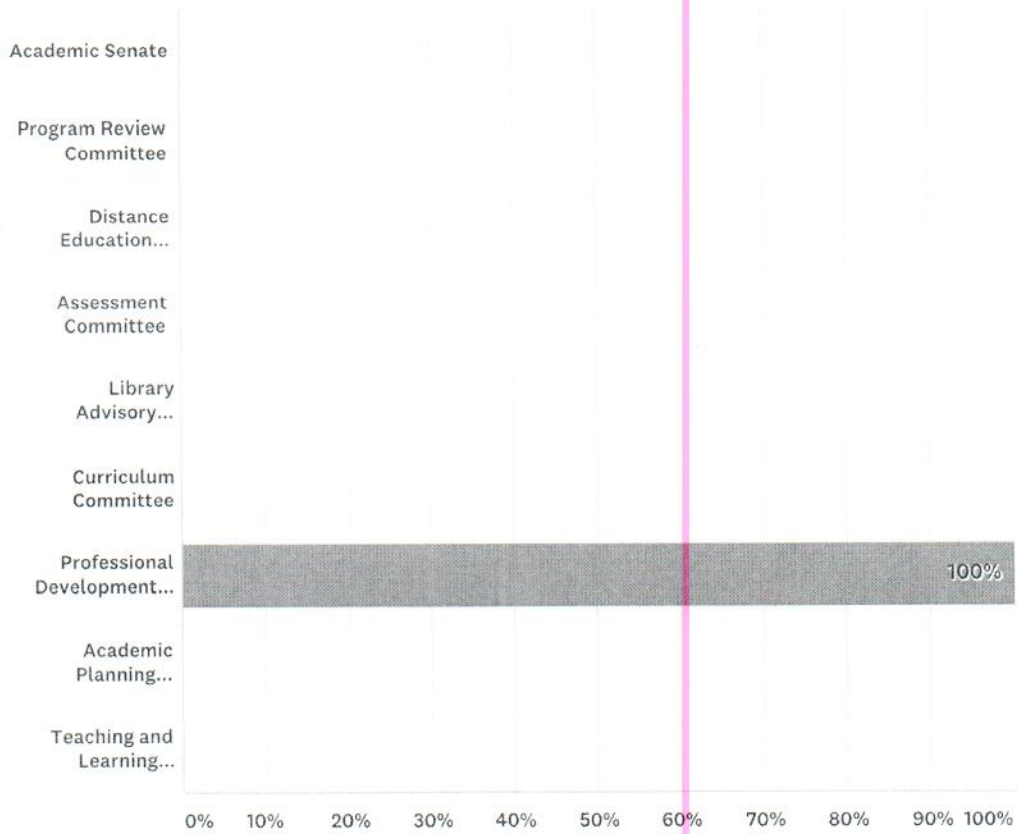

Q1 Which committee are you evaluating today using this survey?

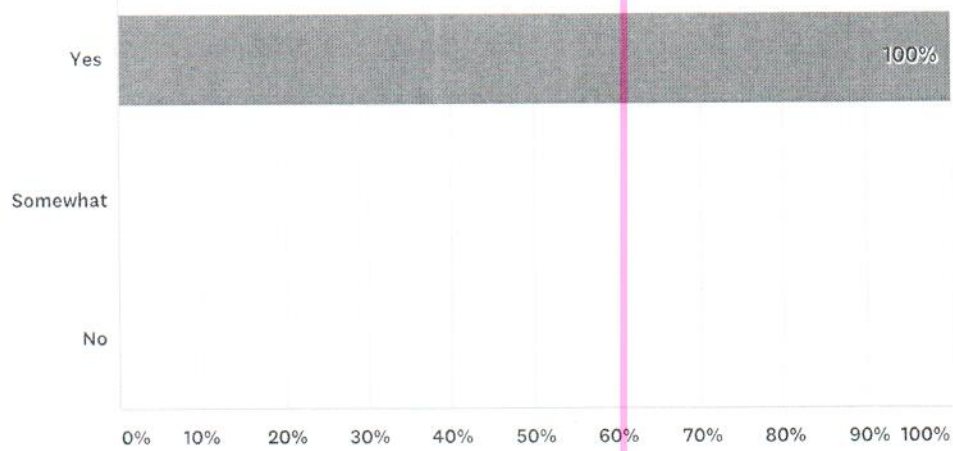

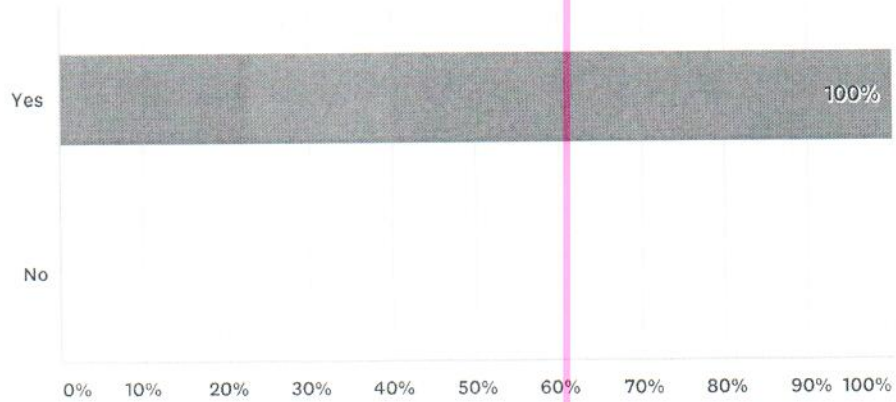

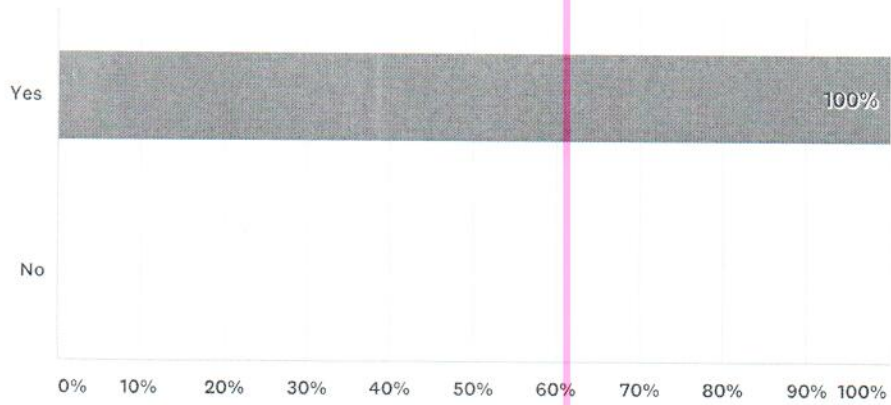

Q4 Are the agenda items usually completed within the meeting time?

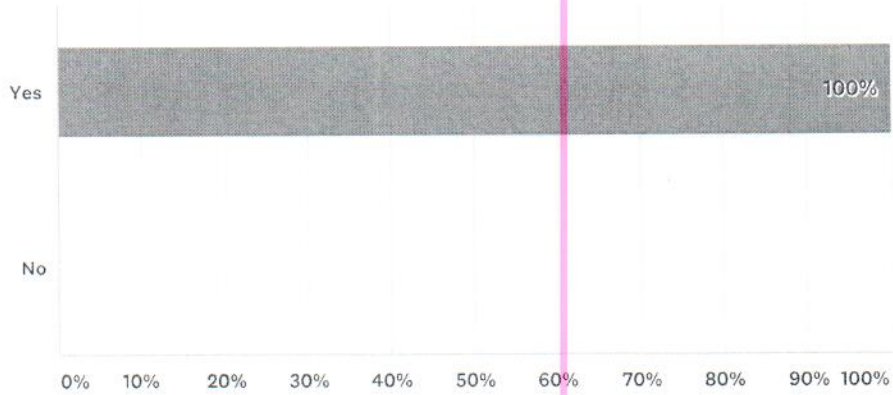

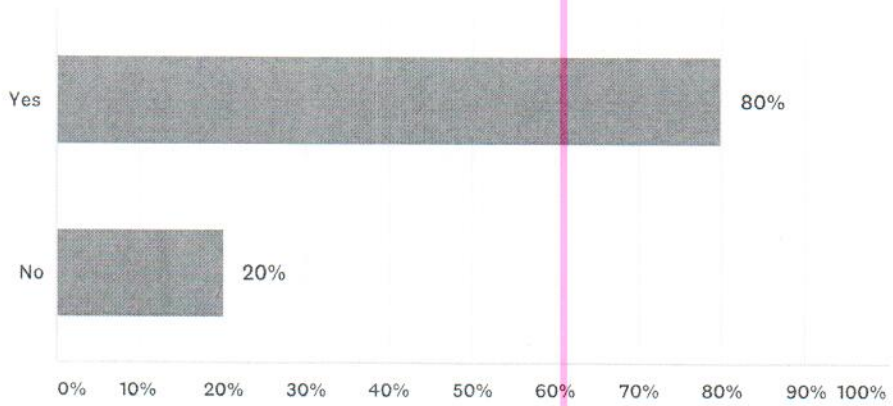
