### B. Technology Committee (Ruth Leal)

Ruth Leal, Technology Committee Co-Chair shared the 2017 Committee Report. (Handout) The committee was updated on several items including computer inventory, technology survey results, and 25Live technology issues.

### A. JFK Middle College HS Update

(Mark DeAsis)

Mark DeAsis presented an update on JFK Middle College. (Handout) Mark introduced JFK Principal, Petria Gonzales, Counselor, Erin Spurbeck, Daniel Landin, Norco College Ed Advisor; and JFK Ed Advisor, Erin Cole. The presentation highlighted wrap-around services, workshops, student ed plans, and the resulting significant increases in AA/AS Graduation, JFK Completion, and persistence rates. The team discussed future plans which include ongoing assessment of the program, a ribbon cutting for the Norco College

Resource Center at JFK, the possible expansion to serving 9<sup>th</sup> graders, and marketing of the program.

Questions/Comments:

Congratulations and thanks were extended to the team for their hard work, dedication, and success of the program.

B. Veterans Resource Center

(Bryan Reece)

Dr. Reece provided an update progress made for development of the Veterans Resource Center including location, partnerships with RCOE for childcare, financing options for housing, and plans for a regional Vets Center. The committee was updated on progress and plans for awarding college credits for training received while serving. We have applied for Strong Workforce funds in partnership with MSJC and Crafton Hills College to aid the effort. Faculty are working on mapping AFS and MOS to our Gaming and Logistics curriculum. We will begin a marketing campaign in the spring to gauge interest.

Questions/Comments:

- Are we the only college attempting to map military training to college course credit?
  - If done well, we would be the first.
- Questions of zoning and safety were raised.
- If housing is going to be built, consideration for families/children's needs should be considered (i.e. housing should be attractive and include amenities like a playground)

## Fund Agreement between Norco College Student Services and the Riverside Community College District Foundation October, 2017

The Norco College Student Services department wishes to establish a permanently restricted fund with the RCCD Foundation, a California non-profit corporation, with the conditions and purposes contained in this document. This fund is being established through the generous contributions of the faculty and staff of Norco College to commemorate the college's 25<sup>th</sup> anniversary. The name of the fund will be the *Norco College Silver Scholarship Endowed Fund* (Endowed Fund).

### I. ESTABLISHMENT OF FUND

This Fund will be deemed established when:

- a. This Memorandum has been reviewed, signed and dated by the appropriate College and Foundation officials.
- b. Funds have been received and deposited for the purpose cited herein. It is the intention for this Fund to receive contributions from various donors.

### II. PURPOSE AND USE OF FUND

The Endowed Fund will be used to provide scholarship support for students at Norco College.

### III. AWARD CRITERIA AND SELECTION PROCESS

The Endowed Fund will be administered by the RCCD Foundation in cooperation with the Office of Financial Aid in accordance with established procedures prescribed and managed by these departments. Scholarship recipients will be selected from a pool of candidates who meet the following criteria:

- a. Norco College students only
- b. 2.50 minimum grade point average
- c. Continuing students
- d. Part time enrollment (fewer than 12 units)

The number and amounts of scholarship awards will be defined by the selection committee and may vary each year depending upon the level of funding available from the Endowed Fund. The establishing department's preference is for at least two scholarships to be awarded each year, each with a minimum amount of \$500.

In any year when there are no candidates who meet the eligibility criteria, the award may be held until a future year when there are eligible recipients. In any year when more than two students stand out from the pool of eligible recipients, more than two awards may be given provided there is sufficient funding for each award to be at least \$500.

### ADMINISTRATION OF ENDOWMENT FUND

The corpus of the Endowed Fund will be held inviolate by the Riverside Community College District Foundation in perpetuity and administered according to the RCCD Foundation

Investment, Spending, and Administrative Allocation Policy. Only the income from such investment shall be expendable for the purposes stated in this Agreement. Income which is not expended during the year for which it is allocated may be held for future use or reinvested into the principal.

The establishment and administration of the Endowed Fund will comply with current policies of the Riverside Community College District Foundation. Although the Endowment is intended to exist in perpetuity, unforeseen circumstances may alter or remove the subject area from the college academic plan. In such an event, the College President is authorized to re-designate the purpose of this Endowment, in consultation with the RCCD Foundation Board of Directors, as s/he determines to be consistent with the original intent of the Endowed Fund.

An annual administrative fee will be assessed in accordance with standard Foundation policy. This fee is currently 1% of the corpus of the Endowed Fund.

Additions to the Endowed Fund may be made at any time. Such additions shall be subject to current RCCD Foundation gift policies and subject to an administrative gift fee, which is currently 5%. Additions to the Endowed Fund will be commingled with the original corpus and subject to the provisions of the Agreement.

### **SMOKING POLICY**

Smoking of any form of tobacco or non-tobacco products is prohibited on District grounds, in all District vehicles, at any activity or athletic event and on all property owned, leased, or rented by or from the District, unless a tobacco use area has been designated. Norco College has designated available smoking areas. Please see the campus map on page iv for specific locations. Locations subject to change.

The Board of Trustees, students and staff of the District recognizes the serious health problems associated with smoking tobacco or other non-tobacco products and the use of smokeless tobacco. It is also recognized that tobacco smoke poses a health risk to non-smokers. Although it is desired that the District maintain a smoke free environment, the Board recognizes the need for each campus to determine whether or not their campus should be completely smoke free or have designated smoking areas. Therefore, each campus, through their Strategic Planning Committees, will make that determination for themselves. District Administration will make the determination for all buildings that house District services (currently RCCSO, North Hall, College House, Alumni House and Spruce St. Offices)

- I. Smoking of any form of tobacco or non-tobacco products is prohibited in all District vehicles, or at any RCCD sponsored activity or athletic event.

Smoking of any form of tobacco or non-tobacco products is prohibited inside any indoor area or within 20 feet of a main exit, entrance, or operable window at District Office buildings, (which includes RCCSO, Alumni House and Spruce St.).

The Riverside City College Campus, (which includes North Hall, the College House, the Culinary Academy and the Rubidoux Annex), and the Moreno Valley College, (which includes the March Education Center and March Dental Education Center), are completely smoke-free environments and smoking is prohibited on any of these properties, including parking lots.

The Norco College has designated smoking areas, which are: In the circle between the library and the Applied Technology Building, the east side of the Applied Technology Building and in the west end quad. For a map detailing the location(s) of these designated smoking areas, please contact the office of the Vice President of Academic Affairs at the Norco College. Smoking in any other areas of this campus is prohibited.

- II. These procedures apply to employees, students, visitors and other persons who use the facilities on the college campuses or any other buildings/property that are part of the Riverside Community College District.
- III. The District shall make available to employees and students a current referral list of smoking cessation programs and other information and literature on the subject of smoking that may assist individuals who wish to stop using tobacco products. Such information shall be available in the Health Services Office on any of the college campuses.

**COMMITTEE STATEMENT OF PURPOSE:**

- Norco Legacy is a mindful group of colleagues that proudly represents the diverse Norco College community. We listen and respond to the concerns and needs of our community. We advocate and facilitate respectful interactions with an appreciation for diversity. We build a culture of practices to promote inclusiveness, dialog, and harmony.

**STRATEGIC GOALS AND OBJECTIVES THAT APPLY TO THIS COMMITTEE:**

***GOAL 2: IMPROVE THE QUALITY OF STUDENT LIFE***

**Objective 4:** Increase the percentage of students who consider the college environment to be inclusive.

- The Legacy Committee contributes to achieving this objective by identifying ways in which it can support students to get the most of their education. Legacy values students as individuals by creating an inclusive environment at Norco College. This years planned events are ways in which Legacy will promote inclusion of all students through the use of educational events and celebrations:
  - **October 2017** (#whatsyourstory, Panel on Sexual Orientation & Gender Identity)
  - **November 2017** (Panel discussion on racial protest in today's America)
  - **February/March 2018** (Public Speaker, Topic TBD)
  - **April 2018** (Fourth annual "Day of Inclusiveness", Club Booths, Music, Food (etc.)

**Objective 5:** Decrease the percentage of students who experience unfair treatment based on diversity-related characteristics.

- Legacy will work on this objective by promoting inclusiveness, scheduling diversity-related activities/discussions, and advocating for those who feel they are experiencing unfair treatment.

***GOAL 7: STRENGTHEN OUR COMMITMENT TO OUR EMPLOYEES***

**Objective 2:** Increase the percentage of employees who consider the college environment to be inclusive.

**Objective 3:** Decrease the percentage of employees who experience unfair treatment based on diversity –related characteristics.

**Objective 4:** Increase participation in events and celebrations related to inclusiveness.

- A campus climate survey was completed in Spring 2016. We used Educational Advisory Board's (EAB) campus climate survey and added three questions specific to our college. The survey was primarily focused on assessing students and employees' general welfare and sexual misconduct. Spring 2017 there was the Institutional Effectiveness and Planning Survey that asked Diversity questions for employees on campus. There will be another employee survey in Spring 2018, Great Colleges to Work for Survey.
- Legacy will continue to work on increasing participation by scheduling events during various days/times, especially during college hour and after 5 pm. We will also strive to advertise events in a timely manner to increase attendance. When deemed appropriate, faculty will be encouraged to send their students to educational events and we will work with PDC to offer FLEX credit.

## **ACTION PLANS:**

In order to accomplish the objectives set forth, the Legacy committee has completed and/or is planning the following activities:

1. Continue to sponsor and coordinate the Norco College Legacy Committee Diversity Award nomination and selection process (April-May).
2. Coordinate Ethnic/Culture specific events/discussions along with Day of Inclusiveness (1 or 2 major events per term).
3. Create social media pages to help promote diversity on campus.
4. Collaborate with ASNC and other departments/committees to co-sponsor events.
5. Collaborate with Read to Succeed Program to focus readings on diversity and inclusivity topics.
6. Look at data and identify other campus climate surveys to implement in FY 17-18.

## **HOW DOES THE COMMITTEE ALIGN WITH NORCO'S COLLEGE MISSION?**

- The work done by the Legacy committee is directly related to the mission, which states that, "Norco College serves our students, our community, and its workforce by providing educational opportunities, celebrating diversity, and promoting collaboration." Legacy develops numerous events that promote inclusiveness and diversity.

## **CHALLENGES:**

- Legacy planned and implemented too many events for the 2016-2017 fiscal year, which have been marginally successful. To improve on the quality of events and increase participation, we are going to focus our efforts on planning no more than 2 major events per term. We will work with PDC to offer Flex Credit, and reach out to faculty to help with student attendance.

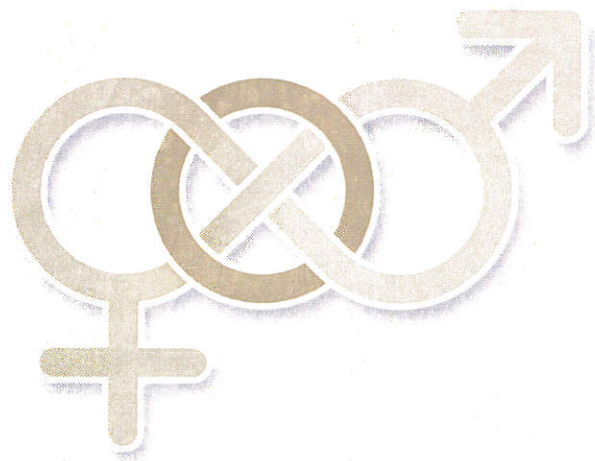

# TECHNOLOGY COMMITTEE REPORT

## FALL 2017

### COMMITTEE STATEMENT OF PURPOSE

*The Norco College Technology Committee provides recommendations for the strategic direction, implementation and sustainability of technology resources throughout the college to support student learning programs and services and improve institutional effectiveness consistent with the college's mission.*

### STRATEGIC GOALS AND OBJECTIVES:

#### **GOAL 5, OBJECTIVE 5: INCREASE THE NUMBER OF FACULTY DEVELOPMENT WORKSHOPS FOCUSING ON PEDAGOGY EACH ACADEMIC YEAR**

##### **Technology Training**

- The Technology Strategic Plan has goals regarding the tools for online faculty and online students but these objectives are being advanced in the Distance Ed Committee.

#### **GOAL 6, OBJECTIVE 4: INSTITUTIONALIZE THE CURRENT TECHNOLOGY PLAN**

##### **Technology Recommendations in Strategic Planning**

- The process of technology requests from program review and the evaluation/recommendation by the Technology Committee is documented in the *Technology Principles and Guidelines* and is part of strategic planning.
- Based on the Refresh Plan in the *Replacement of Technology Infrastructure and Equipment Plan*, the committee makes an annual recommendation of approximately 25% of the computer inventory to be refreshed. Two refresh cycles have taken place with an adjusted third cycle in this year's program review. A new inventory needs to be conducted.
- The committee conducted the annual technology survey in spring to gather input from the college community on technology and is used as a basis for training and resource recommendations.

##### **Annual Technology Survey**

- 2017 Technology Survey was completed by 55 faculty (37 full-time, 18 part-time), 31 staff (26 full-time, 5 part-time) and 125 students (79 full-time, 47 part-time).
- Satisfaction with the college computer performance remained the same from faculty but dissatisfaction decreased for staff by 21%. The survey also reflected a decrease in the percentage of faculty and staff who had problems or have an outdated computer. The committee plans to follow-up on the refresh plan phases I and II to confirm the computers were replaced.
- Faculty and staff felt there was sufficient technical support at Norco College but it decreased by 20%. Comments stated the need for a local troubleshooting help desk as an area to improve tech support.

- Survey feedback from faculty and staff included: slow response times to work-orders, the need to talk to someone on campus, software not updated, slow wi-fi, and the need for tech support at night for adjunct faculty.
- Based on the survey, students receive their news/information from the college via student email (91%), Norco College website (73%), WebAdvisor (55%), and posters/flyers on campus (41%).
- Students would like to see texting notifications when class is cancelled, e-books, bring your own device in the classroom, and online tutoring with teachers as well as better wi-fi and updated computers on campus.

## **GOAL 7: PROVIDE PROFESSIONAL DEVELOPMENT ACTIVITIES FOR ALL EMPLOYEES**

### **Technology Resources**

- Lynda.com is used by faculty and staff for professional development. 76 full-time faculty, 59 part-time faculty, and 72 staff have accounts to access the technology training resource.
- The committee conducted a technology workshop for staff on August 3, 2017 that was well attended. Over 30 staff members attended training on 25 Live. The committee is planning technology workshops for faculty and staff again this fall and winter.
- This goal fits with the Technology Strategic Plan

### **HOW DOES THE COMMITTEE ALIGN WITH NORCO'S COLLEGE MISSION?**


- The committee provides educational opportunities for faculty, staff, and students through Lynda.com online technology training and face to face technology workshops.
- The committee continues to research and discuss the creative application of emerging technologies for the college.
- The committee systematically assesses technology resources and uses the results of evaluation as the basis of recommendations for technology to support student learning.
