- a. Feedback for the PRISM / Unity Zone Canvas shell (C. Young)

- Review of the new PRISM & Unity Zone Canvas shell.

e. Gender Markers resolution (P. Campo)

- Jan Muto & Peggy Campo drafted a resolution concerning making sure students, faculty, and classified professions can voluntarily identify their gender identity, sexual orientation, preferred name, and gender marker.
- Minor editing/proofreading suggestions were made, phrases shifted to ensure parallel construction.
- Added preferred pronouns to the first RESOLVED statement.
- Added gender marker to the second RESOLVED statement.
- Peggy will forward the edited document to Jan. They will review and submit to academic senate.
