#### 2.3 Student Art Relocation Proposal – Claudia Figueroa (Handout)

- The council members reviewed a presentation requesting student art that is requested to be moved from the Counseling area to the LRC hallway. The art was removed from Counseling and is currently residing in the art archives. The DEIA committee supports this request and the relocation would follow their charge.
- The new location is 1<sup>st</sup> floor Library/LRC specifically near Lib110 which is where various clubs use during class breaks. (Dreamers/Chingonas Breakfast Club/Future Loteria)
- A question was raised on hanging requirements for each of the art pieces and facilities confirmed they would be secure.
- A question was raised on when the Library/LRC is remodeled, will the art be automatically transferred back to that location after the construction. Dr.
   Collins said it would be discussed in this committee once the new construction has been completed.
- o Dr. Collins will deliver the proposal to Executive Cabinet with the Resources Council recommendation of approval.

#### 3. Discussion Items:

#### **3.1 2025-2030 Resource Council Charter Draft** (Handout)

- The council members reviewed the first initial draft of the new charter for 2025-2030.
- A suggestion was made to add "District" before "College Budget" under the section labeled: Required reports and updates.
- An observance was made that the listing for membership is missing from this new template. Dr. Collins will confirm with Dr. James, even though the link to the membership committee on our webpage is listed further down the document.
- It was also questioned if the document is approved until 2030, the co-chair listing may change during that time frame. Dr. Collins will also confirm with Dr. James on this.
- A request was made to add the titles to the Resource Council committee members on the website.
- Equity focus area still needs clarification.
- The current RC co-chairs will meet to clarify, discuss, and update the charter for the November meeting to review and vote to approve.

- Councilmembers reviewed the new charter requirements, procedures, and template provided by College Council.
- A question was raised if we had an "equity focus" in the last charter, which will be looked at.

- Questions were raised and addressed during the presentation:
  - The BAM percentage was lower the anticipated at the beginning of the year (due to not producing the estimated FTEs)
  - We need to focus on overloading and part-time faculty budget allocations moving forward. It is possible to over-schedule classes, which potentially causes us to run a deficit. One of the many reasons we need to look for more efficiency. Some areas might naturally have inefficiencies due to extra safety or supporting measures needed to be successful with their designated course caps (Example: Labs, etc.). Many colleges have these same issues. We identify understand that the summer and winter classes typically cost more with overloads. The current district methodology to fund FTEs between full time and part time faculty will be continue to be reviewed and improved.
  - OCOVID Block Grant funding continues to support some counseling faculty at this time. A question was raised on why the Counseling Faculty (1400 budget lines) continues to omitted from the full time faculty funding (1300 budget line). Dr. Collins explained when new counseling faculty is hired, we don't see a reduction in one budget to the other (part-time faculty that support clubs, special programs, etc. can also be funded by one time funding, which we are trying to move off from).
  - o Holding Accounts: In the past few years, we have held the match of 4+million for the CHP&K building funding. The district has since then stated that the college had to come up with funding for the remodel of the STEM renovation and wants to use the 4.4 million we were holding for CHP&K in the meantime. (The details are highlighted in the spreadsheets that were provided)
  - o Contractual costs rising such as step increases, health & welfare, infrastructure expenses and the college has to account for that.
  - o It was noted that Instructional Equipment funding has not been provided by the state for the past few years, so the college has to account for those improvements as needed. And those equipment pricing expenses are all going up with inflation as well.
  - As COViD block grants goes away (one-time funding) our equipment/technology/software/marketing/counseling/mental health services will have to be funded by Fund 11 starting around the 2026/27 fiscal year.
  - 25/26 District final budget allocation model was shared and it was determined by FTEs growth. The current percentages would be: NC 21.88% MVC 24.05% and RCC 54.04%
  - The state budget seems to be on a decent footing for 26/27. However, the 2028/29 budget will most likely begin to show issues of deficits with the state revenue in the future.
  - Student Block Grant is for student base funding, non-resident tuition, student head count, etc. We can use the funding for such student items as: food, housing, transportation, childcare, financial and academic advising, mental health services, job placement, etc.
  - Facilities expenditures were detailed with ongoing costs continuing to increase and as our infrastructure ages, we will have more and more unexpected issues (water lines breaking, electrical & HVAC issues, etc.)
  - o It was asked if the new charging stations would generate revenue. It was stated that the users would pay the vendor directly.

#### **4.3 Facilities Update** (Handout)

 A detailed update was provided with construction progress reports, current projects, etc.

• Travonne Bell reported that he gave a formal recommendation for the addition of an ADA push button access to the front door at STEM center, and it was approved.







#### **Draft Charter Instructions**

#### **Charter Requirements**

Charters at Norco College serve two purposes:

- Charters serve as a central location for basic information about each Council and Committee.
- Charters provide a central organizational document to help orient the efforts of Councils and Committees regarding their contributions to the operational and strategic efforts of the college.

All charters contain the following elements:

- Name of Council/Committee
- Description: a 25-50 word overview (brief and descriptive) of the Council/Committee's mission or central charge.
- Brown Act: identification of bodies subject to the Brown Act
- Meeting Schedule: regularly occurring meeting schedule
- Chair/Co-Chairs (include constituent group when relevant)
- Reports and Recommends to: the governance entity or office that the council or committee reports and submits recommendations to
- Required Reports and Updates: specific reports and updates related to institutional effectiveness and strategic goals
- Key Performance Indicators/Goals: specific KPIs or Goals that the Council/Committee has been assigned and the specific KPIs or Goals that the Council/Committee has chosen to pursue.
- ACCJC Accreditation Standards: alignment to specific standards that guide the committee or council's work
- Equity Focus: a brief statement about how it will contribute to the development of equity at the college, including but not limited to equity-focused efforts, populations, or initiatives.
- Edition Date: date of their most recent revision and dates of previous versions of the charter.
- Link: Provide URL to site with Membership Roster.

Refer to the Charter Procedures (under Governance Procedures) prior to making changes to any of the above charter elements.

#### Websites

All Councils and Committees of the College are expected to maintain websites related to their group. While other groups should determine on their own whether a website is necessary, in general, groups are encouraged to establish and maintain websites to facilitate communication and openness. Previously, there have been no guidelines on what websites should contain. These guidelines aim to establish a more uniform, college-wide approach to website development and maintenance.

#### **Website Guidelines**

All College group websites are expected to have the following elements. Please note that these elements are considered only a starting point and that groups can and likely should include additional information beyond these guidelines to carry out the group's charge best.

The expected elements consist of the following:

- Name.
- A description of the group's purpose and/or the group's mission statement.
- The regular meeting dates, times, and locations, including physical and virtual as appropriate.
- Contact information.
  - The primary contact will likely be the chair or co-chairs.
  - o Contact information should include how to submit items for the group's agendas.
- Meeting Schedule
- Committee Members
  - Group Membership should be updated at least annually and ideally at the beginning of each semester.
  - Chairs/co-chairs should be clearly identified.
  - If a group's membership is based on representation from particular College communities, those affiliations may be included (i.e., the Student Representative may be identified as such, or the Representative from a particular School or constituent group may be identified as such).
  - A statement regarding how group members are selected or who is welcome to join the group.

- Archived Agendas and Minutes

#### **Responsibility for Website Updates**

All groups with a website should assign a person or team to be formally responsible for updating the website (either directly or by working with College or District IT to implement the updates). While this responsibility will commonly fall to the chair/co-chairs, any group member can perform this task. The person/team assigned should expect to perform the following duties:

- Review the website at the beginning of each semester to identify needed updates. Examples of common updates include:
  - o Changes to group roster or membership.
  - o Changes or updates to meeting days, times, and locations.
  - Changes to any linked documents, guides, or other resources provided to the community.
- Perform a monthly review and update of the council/committee website to ensure documentation is uploaded and accessible. This includes agendas with documentation and meeting minutes.
- At the conclusion of each term (Fall and Spring), work with the College or District IT for assistance and support as needed to ensure the site is fully functional and up to date.

#### **Charter Procedures**

**Purpose**: To ensure that each governance charter provides accurate and up-to-date information to orient the efforts of the council or committee regarding their contributions to the operational and strategic efforts of the College through regular review and examination of the charter.

**Scope**: Governance entities can create new charters at any time during the five-year strategic planning cycle. All governance entities shall seek reauthorization of existing charters in years two and four of the five-year strategic planning cycle as part of the Governance Self-Evaluation and Continuous Improvement Process.

**Timeline**: Each governance entity conducts an annual internal review of its charter for updates and revisions, led by the chair or co-chairs. In years two and four of the five-year strategic planning cycle, each governance entity will participate in the Governance Self-Evaluation and Continuous Improvement Procedures, which includes a formal and in-depth review of the charter in response to the Report of Effectiveness.

**Procedures**: Charter procedures define the required charter elements as well as the process for review and updating charters. The first set of instructions is for the creation of new charters, followed by the procedures for the reauthorization of existing charters.

#### **New Charter Instructions:**

- 1. **Creation of New Charter**: Any member of a constituent group at the college may propose a new council, committee, or other group that aligns with and supports the College's strategic goals. The following charter elements are required:
  - Name of Council/Committee
  - Description: A 25-50 word overview (brief and descriptive) of the Council/Committee's mission or central charge.
  - Meeting Schedule
  - Chair/Co-Chairs (include constituent group when relevant)
  - Membership: names of members and relevant constituent groups (e.g., faculty, classified professionals, etc.) from which each membership is drawn.
  - Key Performance Indicators/Goals: Specific KPIs or Goals that the Council/Committee has been assigned and the specific KPIs or Goals that the Council/Committee has chosen to pursue.
  - Equity Focus: A brief statement about how it will contribute to the development of equity at the college, including but not limited to equity-focused efforts, populations, or initiatives.
  - Edition Date: Date of their most recent revision and dates of previous versions of the charter.
  - Support Staff: Support staff assigned to the Council/Committee
- 2. **Feedback and Approval**: The new charter will be presented to the appropriate governance entity (i.e. one of the four leadership councils or Academic Senate) authorizing body to examine and discuss mission alignment and strategic goal alignment, as well as compliance with institutional effectiveness procedures.
- 3. **New Charter Recognition**: New charters are subject to additional approval from the following entities:

- a. **Norco College Academic Senate:** Councils, committees, or other groups that impact 10+1 matters as defined by the Educational Code.
- b. **Office of the President:** Councils, committees, or other groups that direct Norco College employees' time and effort. The Office of the President may also delegate charter approval authority to relevant leadership councils.

#### **Reauthorization of Existing Charter Instructions:**

- Review Charter Elements: Each governance entity will annually review the following charter elements to ensure accuracy in composition and purpose, led by the chair/cochairs.
  - Name of Council/Committee
  - Description: A 25-50 word overview (brief and descriptive) of the Council/Committee's mission or central charge.
  - Brown Act: identification of bodies subject to the Brown Act
  - Meeting Schedule: regularly occurring meeting schedule
  - Chair/Co-Chairs (include constituent group when relevant)
  - Reports and Recommends to: the governance entity or office that the council or committee reports and submits recommendations to
  - Required Reports and Updates: specific reports and updates related to institutional effectiveness and strategic goals
  - Key Performance Indicators/Goals: Specific KPIs or Goals that the Council/Committee has been assigned and the specific KPIs or Goals that the Council/Committee has chosen to pursue
  - ACCJC Accreditation Standards: alignment to specific standards that guide the committee or council's work
  - Equity Focus: A brief statement about how it will contribute to the development of equity at the college, including but not limited to equity-focused efforts, populations, or initiatives.
  - Edition Date: Date of their most recent revision and dates of previous versions of the charter.
  - Link: Provide URL to site with Membership Roster.
- 2. **Discuss and Document**: The members will discuss the composition and purpose of the council or committee alongside their Report of Effectiveness and document any recommended revisions to the charter via meeting minutes. Groups are encouraged to engage in dialogue and reflection to continuously improve their efforts.
- 3. **Feedback and Approval**: Charter revisions and recommendations will be presented to the group's governing body to examine and discuss mission alignment and strategic goal alignment, as well as compliance with institutional effectiveness procedures. Minor changes require reporting to the authorizing body, while major changes require approval from the authorizing body.
  - a. **Minor Changes**: Changes that do not require approval include:
    - i. Meeting schedule and location
    - ii. Changes in members or co-chairs
      - 1. Per Senate bylaws, approval is required if a Senate committee wishes to name a non-faculty member as a co-chair.

- b. **Major Changes:** Changes that require approval include:
  - i. The identity of support staff for Senate committees as required by Academic Senate bylaws
  - ii. Group Name
  - iii. Group Purpose
  - iv. Membership structure
  - v. Strategic alignment
  - vi. Change in authorizing body
- 4. **Charter Reauthorization**: Once the authorizing body approves the revised updates and changes, the charter is reauthorized and formally recognized as a governance entity. Any group that does not seek reauthorization or is not granted reauthorization should no longer convene.



### California Community Colleges Budget—Student Block Grant

- The State Budget includes \$60 million one-time to establish the Student Support Block Grant
  - The California Community Colleges Chancellor's Office (CCCCO) will allocate the funds to the community college districts (CCDs) with a base amount of \$150,000 for each college in the district
  - The rest of the funding will be allocated based on the following:
    - Student head count for the most recent fiscal year in which the data is considered final
    - The sum of the following counts of students receiving the California College Promise Grant and students receiving exemptions from nonresident tuition
- The funds can be used for the following:
  - 1) Assistance to students with food, housing, transportation, and basic needs; 2) Childcare subsidies or other assistance for student parents; 3) Financial aid advising or academic counseling; 4) Legal and other support services; 5) Mental health services; 6) Job placement, work-based learning, or reemployment support

### NORCO COLLEGE

### California Community Colleges Budget—Property Taxes and Other Investments

- The State Budget provides \$8.1 million to backfill 2025-26 projected property tax revenue losses from wildfires and \$3.8 million one-time to backfill for 2024-25 property tax revenue losses
- The budget also includes the following investments:
  - An increase of \$10 million ongoing for the Rising Scholars Program
  - \$12 million one-time for the Common Cloud Data Platform
  - \$6.6 million one-time to support e-Transcript California
  - \$20 million one-time for emergency financial aid

  - \$5.1 million one-time for financial aid support and outreach to students
  - \$10 million one-time for Emergency Medical Technician/Paramedic Apprenticeship Academies
  - \$6.33 million one-time for reimbursements for firefighter apprenticeship training
  - \$10 million one-time for Community College Healthy Schools Pathway Program



### **Current & Upcoming Work (Fall 2025)**

- Interior wall framing is ongoing.
- Mechanical ductwork installation continues throughout the building.
- Plumbing and electrical in-wall rough-ins scheduled to begin next week.
- Deeper footing conflicts with sewer line being resolved; footings scheduled for pour this week.
- Exterior trash enclosure CMU block installation starting next week.
- Compaction inspection of front and sidewalk areas to be completed prior to forming.
- Masonry inspection request submitted in preparation for Concrete Masonry Unit (CMU) work.

#### **Next Milestones**

- **Winter 2025/26:** Continue interior wall framing, roof framing, and enclosure work; mechanical, electrical, and plumbing rough-ins to progress through winter.
- Phase 1 completion: February 6, 2026 on schedule.
- Spring–Summer 2026: Phase 2 work includes electrical infrastructure upgrades, new SCE transformer, and switchgear installation. Coordination with SCE ongoing for transformer design and delivery.
