Supply Chain

- Concerns about the PPE supply chain and shortages continue to dominate the public conversation. After yesterday's Task Force press briefing, there are new questions and concerns about the allocation of resources to meet state needs, the intent of the SNS, and who oversees supply chain management.
- This morning traditional media remains focused on the ongoing supply shortages and how the U.S. continues trying to balance refilling the stockpile and directly shipping emergency critical supplies to states in need. FEMA mentions have been moderate and focus on Project Airbridge and the federal response in general.



- FEMA is working with HHS to allocate and deliver key resources from the Strategic National Stockpile, and coordinating with USACE on the build-out of alternate care sites with significant expansion capability
- FEMA continues to work with industry partners on producing, allocating, and distributing PPE and ventilators as quickly as possible
- FEMA Regional Administrators, governors, tribal leaders, state emergency managers, and state public health officials continue to fight the COVID-19 pandemic

Temporary military hospitals will now treat Covid-19 patients, Pentagon says

- The US military will convert three temporary medical facilities in New York, New Orleans, and Dallas into facilities capable of treating patients with the coronavirus, the Pentagon announced Friday.
- "At the request of FEMA, the Department of Defense will expand its medical support to include Covid-19 positive patients at the Javits Federal Medical Station (FMS) in New York City, the Morial FMS in New Orleans, Louisiana, and the Kay Bailey Hutchinson FMS in Dallas, Texas."
- "These three DoD-supported locations will now provide support to Covid-19 positive
 patients in convalescent care, as well as low-acuity patients. These patients, who
 require a lower level of medical care, must first be screened at a local hospital."

Here's what health experts say about face masks

- Dr. Anthony Fauci, the director of the National Institute of Allergy: He said masks should not be used as a substitute for social distancing, but rather can be used as a supplement. "Because of some recent information that the virus can actually be spread even when people just speak as opposed to coughing and sneezing, the better part of valor is that when you're out and you can't maintain that six-foot distance to wear some sort of facial covering." has said that the White House Task Force is actively discussing guidelines on masks.
- "The most important thing is to keep this six-foot physical distance from individuals, but it's become clear that even when you try to do that with certain necessities of life going out to get food or going to a pharmacy to get your medications that you may inadvertently come into closer contact," Fauci, director of the National Institute of Allergy and Infectious Diseases.

Trump says he's invoked the Defense Production Act "against 3M for face masks"

 President Donald Trump said Thursday in additional to the issuance of a memorandum invoking the Defense Production Act to supply ventilator supplies to manufacturers, he has also invoked the act against 3M for face masks.

- In the US, 3M said it expects to produce 50 million 95 respirators per month in June, a 40 percent jump from current levels.
- 3M, which is the largest maker of medical face masks and more specifically the N95 respirator mask, said in a statement earlier this week that it already doubled its global output in January, and also plans "to double our capacity once again, to 2 billion globally within the next 12 months and some of that additional capacity will begin to come online in the next 60-90 days."

Medical supplies seized from seller accused of hoarding get redistributed

- The Health and Human Services Department said Thursday it used its authority under the Defense Production Act to distribute roughly 192,000 N95 respirator masks and a large haul of other scarce medical supplies that the FBI seized during the arrest of a Brooklyn man.
- These supplies were distributed to healthcare workers in New York and New Jersey, HHS said.
- FBI agents, as part of the Justice Department's Covid-19 Hoarding and Price Gouging
 Task Force, seized the items, which in addition to the N95 masks also included:
 598,000 medical-grade gloves, 130,000 surgical and other masks, surgical gowns,
 disinfectant towels, particulate filters, and bottles of hand sanitizer and spray
 disinfectants, the Justice Department and HHS said in a press release.






