#### LA County reports 4 cases of mysterious syndrome in kids linked to COVID-19, 21 suspected cases

- Four children in Los Angeles County who have been diagnosed with a mysterious inflammatory condition also tested positive for COVID-19, and several other suspected cases have also been identified, officials announced Monday.
- County Public Health Director Dr. Barbara Ferrer said that 21 suspected cases have been identified across the region since March 1. The four children were diagnosed with coronavirus through antibody testing, but investigations on the remaining suspected cases are ongoing.

#### PAHO Director calls to protect vulnerable groups from effects of COVID-19 pandemic

- "The virus is surging across our region. We are increasingly worried about the poor and other vulnerable groups at greatest risk of illness and death from the virus. The recent spike in cases and fatalities is partly due to the virus taking root in these groups."
- "During a pandemic, we must overcome the structural inequalities that limit access to services. This means establishing
  mechanisms that support universal access to health regardless of income, pooling resources with the private and not for profit
  sector, eliminating payment at point of service and setting up emergency hospitals that add surge capacity where it is most
  needed."
- Women, who make up 70% of the health workforce in the Americas, are also vulnerable, as they are on the frontlines and disproportionately affected by COVID 19, Dr. Etienne noted. #### FEMA publishes COVID-19 Pandemic Operational Guidance for the 2020 Hurricane Season

• In preparing for the 2020 hurricane season and to address the challenges of managing disaster response and recovery efforts during this year's hurricane season, FEMA is releasing the "COVID-19 Pandemic Operational Guidance for the 2020 Hurricane

Season" to help emergency managers and public health officials with actionable guidance to best prepare for disasters and encourages personal preparedness measures while continuing to respond to and recover amidst the ongoing COVID-19 pandemic.

 While this guidance focuses on hurricane season preparedness, most planning considerations can also be used by private sector and non-governmental organizations to gain an understanding of the government's posture, planning and readiness efforts, and can be applied by private sector and non-governmental organizations to gain an understanding of the government's posture, planning and readiness efforts any disaster operation environment, including no-notice incidents, spring flooding and wildfire seasons, and typhoon response.

#### OSHA Revised Enforcement Guidance for Recording Cases of Coronavirus Disease 2019 (COVID-19)

- This memorandum provides updated interim guidance to Compliance Safety and Health Officers (CSHOs) for enforcing the requirements of 29 CFR Part 1904 with respect to the recording of occupational illnesses, specifically cases of COVID-19. On May 26, 2020, the previous memorandum on this topic[1] will be rescinded, and this new memorandum will go into and remain in effect until further notice. This guidance is intended to be time-limited to the current COVID-19 public health crisis. Please frequently check OSHA's webpage at www.osha.gov/coronavirus for updates.
- Under OSHA's recordkeeping requirements, COVID-19 is a recordable illness, and thus employers are responsible for recording cases of COVID-19, if:
  - The case is a confirmed case of COVID-19, as defined by the Centers for Disease Control and Prevention (CDC);[2]
  - The case is work-related as defined by 29 CFR § 1904.5;[3] and
  - The case involves one or more of the general recording criteria set forth in 29 CFR § 1904.7.[4] world cut its daily carbon dioxide emissions by 17 percent at the peak of the coronavirus pandemic shutdown last month, a new study has found.

### U.S. Department of Labor OSHA Adopts Revised Enforcement Policies For Coronavirus

- The U.S. Department of Labor's Occupational Safety and Health Administration (OSHA) has adopted revised policies for enforcing OSHA's requirements with respect to coronavirus as economies reopen in states throughout the country.
- Throughout the course of the pandemic, understanding about the transmission and prevention of infection has improved. The government and the private sector have taken rapid and evolving measures to slow the virus's spread, protect employees, and adapt to new ways of doing business.
- Now, as states begin reopening their economies, OSHA has issued two revised enforcement policies to ensure employers are taking action to protect their employees.
- First, OSHA is increasing in-person inspections at all types of workplaces. The new enforcement guidance reflects changing circumstances in which many non-critical businesses have begun to reopen in areas of lower community spread. The risk of transmission is lower in specific categories of workplaces, and personal protective equipment potentially needed for inspections is more widely available. OSHA staff will continue to prioritize COVID-19 inspections, and will utilize all enforcement tools as OSHA has historically done.

- Second, OSHA is revising its previous enforcement policy for recording cases of coronavirus. Under OSHA's recordkeeping
  requirements, coronavirus is a recordable illness, and employers are responsible for recording cases of the coronavirus, if the case:
  - Is confirmed as a coronavirus illness;
  - Is work-related as defined by 29 CFR 1904.5; and
  - Involves one or more of the general recording criteria in 29 CFR 1904.7, such as medical treatment beyond first aid or days away from work.

#### Morongo Casino Reopens Friday After Being Shuttered 2 Months

- With major limitations, the Morongo Casino in the Riverside County community of Cabazon will reopen Friday afternoon for the first time since it closed back in mid-March due to the coronavirus outbreak.
- Some slots will be either deactivated or equipped with plexiglass shields.
- All guests and staff must undergo temperature screenings before entry and they must wear masks at all times while inside.
- Its hotel will also reopen with limited capacity.

#### Parking lots at 27 California state parks partially reopen

- 27 California state parks have partially reopened weeks after the 280 state parks and beaches closed their parking lots to discourage non-local visitors, officials said Tuesday.
- Visitors are also advised to check online to see if the park or beach they want to be visit is open before leaving home, what new visitor guidelines are in effect and if parking is available, she said.
- As of Tuesday, 36 parks were closed and 244 were open though campgrounds, restrooms, visitor centers and other facilities remain closed at all state parks.



#### The State of California is currently at Stage 1: Safety and preparedness

- Your Country can apply for a County variance to enter Stage 2
- Stage 2 expansion will be phased in gradually. Some communities may move through Stage 2 faster if they are able to show greater progress. Counties that have met the readiness criteria and worked with the California Department of Public Health can open more workplaces as outlined on the County Variance page.

### **COVID-19 County Variance Attestation Form**

- If a county did not meet the criteria outlined in the prior attestation form and would like to complete the COVID-19 County Variance Form (revised May 18, 2020) in order to move more quickly through Stage 2, a county may do so by submitting the required documentation as specified in the new form.
- The goal continues to be to open the state in a way that minimizes the risk for COVID-19 to the extent possible, which includes: 1) limiting non-essential movement and mixing of populations, especially within jurisdictions with higher confirmed cases, and 2) delaying the opening of environments in which there is prolonged and close contact as part of the way business must operate. CDPH made some changes most notably in the Epidemiologic Stability of COVID-19 section.
- As we continue to move through this process, we recognized a need to make changes to the criteria that counties must meet to move through Stage 2.
