Brazil records more than 100,000 new coronavirus cases in the past 5 days alone

- In the past five days alone, Brazil confirmed more than 100,000 new cases of the novel coronavirus.
- The health ministry reported another 32,000 confirmed coronavirus cases in the past 24 hours, bringing the country's total to at least 772,416.
- The country is also nearing 40,000 deaths from the virus, after recording 1,274 new Covid-19 deaths Wednesday.
- The coronavirus death toll in Brazil stands at 39,680.


White House coronavirus task force will meet today as US cases surpass 2 million

- As the US has passed 2 million confirmed coronavirus cases and a trusted model is projecting a steep increase in the fall, Vice President Mike Pence will lead a White House coronavirus task force meeting today.
- The task force will meet at 2:30 p.m. ET in the Situation Room, according to Pence's schedule. This will be the second meeting this week the group last met on Tuesday.
- As CNN reported last month, the task force has been sharply curtailed, meeting about once a week. Task force members have been
 on conference calls with governors weekly, but there has not been a briefing from the task force since April 27.

NIH researchers identify key genomic features that could differentiate SARS-CoV-2 from other coronaviruses that cause less severe disease

- A team of researchers from the National Library of Medicine (NLM), part of the National Institutes of Health, identified genomic features of SARS-CoV-2, the virus that causes COVID-19, and other high-fatality coronaviruses that distinguish them from other members of the coronavirus family.
- "We were able to identify several features that are not found in less virulent coronaviruses and that could be relevant for pathogenicity in humans. The actual demonstration of the relevance of these findings will come from direct experiments that are currently getting under way."

Protests could spur coronavirus outbreaks, and protesters should get tested, the CDC chief says

- That's the recommendation of the director of the CDC said during a House Appropriations hearing on June 5th that anyone who participated should "highly consider" getting tested.
- "I do think there is a potential, unfortunately, for this to be a seeding event," Dr. Robert Redfield said June 5th. He said the risk of
 infection is higher in major cities where there's been significant transmission. To prevent transmission, Redfield suggested people
 who attend protests tell their loved ones that they were out in public and get tested within 3 to 7 days.

Face Masks And Latex Gloves Have Become A New Environmental Problem

- The Covid-19 pandemic may have given the planet a temporary, though not long-lasting, breather when it comes to air pollution and
 greenhouse gas emissions, but it's also given Earth a new environmental scourge: latex gloves on beaches and sewers filled with
 face masks.
- Although there's no data on the scale of the problem yet, the Associated Press contacted 15 city authorities in the US and all
 reported they had had significantly more sewer clogs and drainage issues since the pandemic began. This might be related to
 people flushing PPE or, they say, it could be due to people flushing alternatives to toilet tissue amid the early-lockdown panic
 buying.

- A North Carolina speedway drew a crowd of more than 2,000 spectators in defiance of the state's coronavirus restrictions after declaring the race a "protest."
- The governor's office had warned Ace Speedway in Elon that a crowd of more than 25 would violate the state's Phase 2 coronavirus restrictions.
- A sign from management outside the speedway said, "This Event is held in Peaceful Protest of Injustice and Inequality Everywhere."
 The Alamance County Sheriff's Office said it is "evaluating the events."

Officials say no turning back on reopening even as coronavirus cases rise

- California officials remain confident about the rapid reopening of the economy even as coronavirus deaths and new cases continue to rise, saying they have no plans now to slow the efforts.
- They said they expected cases to tick upward as businesses reopened but stressed the overall metrics still support the reopening strategy, which took another major step forward on Wednesday.
- "No, we are completely not out of the woods, we are still in in the middle of the woods and we still have a lot of risk," Public Health Director Barbara Ferrer said. "I know how desperate people are to get be able to get back to events but that is not in our health officer order nor is it in the state health officer order."

- "As we phase in, in a responsible way, a reopening of the economy, we've made it abundantly clear that we anticipate an increase in the total number of positive cases," Gov. Gavin Newsom said Tuesday while speaking with Oakland community leaders.
- "But we've also made it abundantly clear the concurrent recognition and commitment that we are in a substantially different place than we were 90 days ago. We have hundreds of millions of masks now in our possession."

California Schools Chief Details Plan for Reopening

- California's Department of Education released a detailed guide Monday for the safe reopening of schools in the age of face masks and physical distancing to prevent the spread of the coronavirus
- "The COVID-19 pandemic has had a devastating effect on everything we know about providing education," said State
 Superintendent of Public Instruction Tony Thurmond. "It forces us to enter into a new conversation about the way we provide
 instruction."
- The manual titled, "Stronger Together: A Guidebook for the Safe Reopening of California's Public Schools," can serve as a road map for school districts as they prepare for the return of classes in the fall, Thurmond said.
- The state cannot order schools to adopt its rules, but its guidance serves as recommendations for districts to follow on reopening.
 School districts opted to close when Gov. Gavin Newsom issued a statewide stay-at-home order in mid-March and developed distance-learning plans on the fly.
- The California Education Coalition, which includes the nine statewide K-12 public education associations, has urged Newsom and state legislators to reject the cuts. Teachers, superintendents, principals and others say they support the need to implement physical distancing at schools, which would require decreased class sizes and dramatically increased cleaning in classrooms and across campuses. But all of that will cost more money.

- The three main elements of their Anaheim, California, campus will begin with the reopening of the shopping district in Downtown Disney on July 9, theme parks Disneyland and California Adventure on July 17, and hotels Paradise Pier and Grand Californian on July 23.
- As theme park capacity will be limited, Disneyland will implement a new reservation system along with new health and safety protocols.

Covid-19 Case Cluster (past 48 hours)





- Outdoor museums, open gallery spaces and other public spaces with modifications

Expanded Stage 2 with Attestation: Upcoming changes in the Stay-at-Home Order will move the entire state methodically through opening further. Those counties with variation attestation may progress to open these sectors more rapidly, according to their county-specific plan for modification.








