### WHO welcomes preliminary results about dexamethasone use in treating critically ill COVID-19 patients

- Initial clinical trial results from the United Kingdom (UK) that show dexamethasone, a corticosteroid, can be lifesaving for patients who are critically ill with COVID-19. For patients on ventilators, the treatment was shown to reduce mortality by about one third, and for patients requiring only oxygen, mortality was cut by about one fifth, according to preliminary findings shared with WHO.
- The benefit was only seen in patients seriously ill with COVID-19, and was not observed in patients with milder disease.
- “This is the first treatment to be shown to reduce mortality in patients with COVID-19 requiring oxygen or ventilator support,” said Dr Tedros Adhanom Ghebreyesus, WHO Director-General. “This is great news and I congratulate the Government of the UK, the University of Oxford, and the many hospitals and patients in the UK who have contributed to this lifesaving scientific breakthrough.
- Dexamethasone is a steroid that has been used since the 1960s to reduce inflammation in a range of conditions, including inflammatory disorders and certain cancers. It has been listed on the WHO Model List of Essential Medicines since 1977 in multiple formulations, and is currently off-patent and affordably available in most countries.

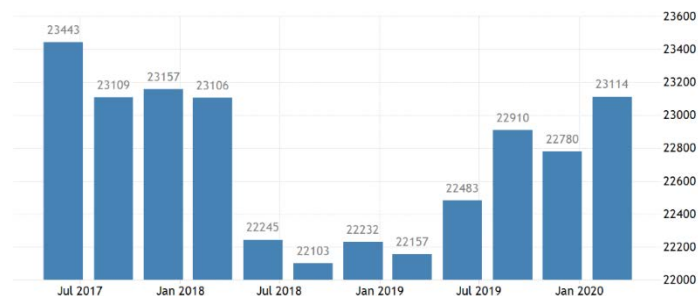


## 24 Hour Fitness Files Bankruptcy, Anticipates \$250MM in DIP Financing

As with the existing Main Street Lending Program, which targets small and medium-sized businesses, the proposed expansion would offer loans to small and medium-sized nonprofits that were in sound financial condition before the coronavirus pandemic and could benefit from additional liquidity to manage through this challenging period.

"However, beyond the initial rebound in the housing market, the economic and housing outlook will be heavily impacted by the prospects for a vaccine, fiscal policy and the underlying organic recovery of the economy which, in combination, make the outlook highly uncertain."

## Cathedral City votes to require the use of face coverings until September 30

- Cathedral City councilmembers voted to approve an emergency order which mandates the use of face coverings and social distancing until September 30, unless it is extended or rescinded.
- The order includes fines that range from \$100 to \$500 depending on how many times a person is found violating the order.
- Face coverings and social distancing are required while in public, including all essential workers, with the following exceptions:
  - When at home
  - Driving alone in the car or with members of their household
  - Children under the age of 2 years
  - While outdoors and/or exercising outdoors as long as you practice social distancing of at least 6 feet between others and have a face covering readily accessible if you encounter others and are unable to social distance.(walking, hiking, golfing, etc.)
  - Those who have a medical condition that prevents the use of a facial covering and certified by a medical professional.
- Businesses in the city are also required to:
  - Require all employees, contractors, owners, and volunteers to wear a face covering at the workplace
  - Inform customers to wear a face covering – including posting signs and advising those standing in line
  - Take reasonable steps to keep people who are not wearing a face covering from entering the business
  - Refuse service to anyone not wearing a face covering
  - Face coverings are defined as dense fabric without holes, bandanas, neck gaiter, or other fabric face coverings.

## Temecula Businesses Are Expanding Outdoors Amid Coronavirus

- The city is offering businesses the opportunity to apply for no-cost permits that allow outdoor dining, retail, and other activities.
- To help facilitate social distancing amid coronavirus, many businesses that have been allowed to reopen in Temecula may start serving customers indoors and out.
- To facilitate the process, the city announced it is allowing restaurants, retailers and other businesses to apply for no-cost temporary outdoor expansion permits. For example, beginning June 24, portions of Old Town Front Street will temporarily close to vehicular traffic so businesses can expand their footprint onto sidewalks and into the street for dining and shopping.

- According to an announcement Wednesday from the County of Riverside, the personal care business sectors that can reopen June 19 include:
  - Nail services
  - Facial and esthetician services
  - Shaving, waxing and threading services
  - Massage therapy services
  - Body art, tattoo and piercing services
- Hair salons and barber shops reopened May 26.
- Additionally, wedding ceremonies can resume, but wedding receptions are not allowed under the state's stay-at-home order, the county said. Libraries may also reopen.

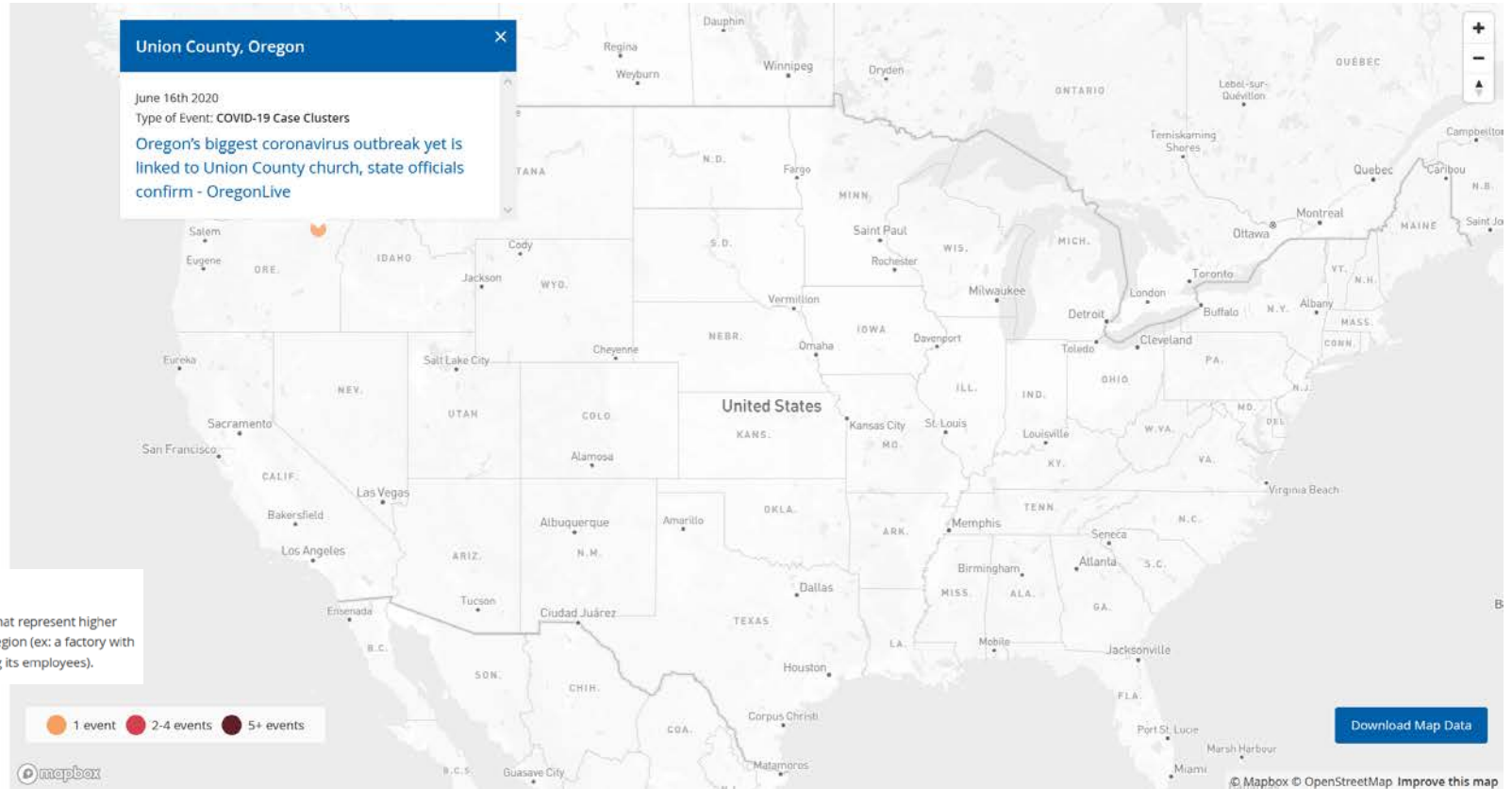

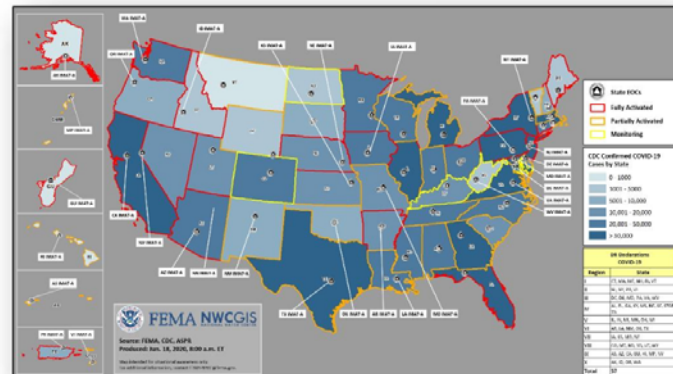

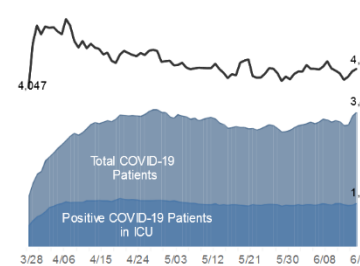

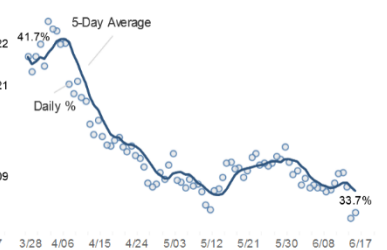

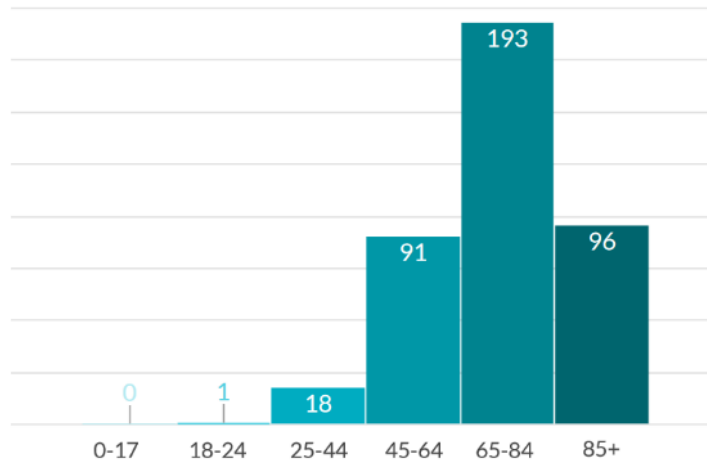

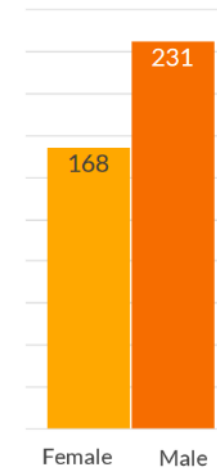

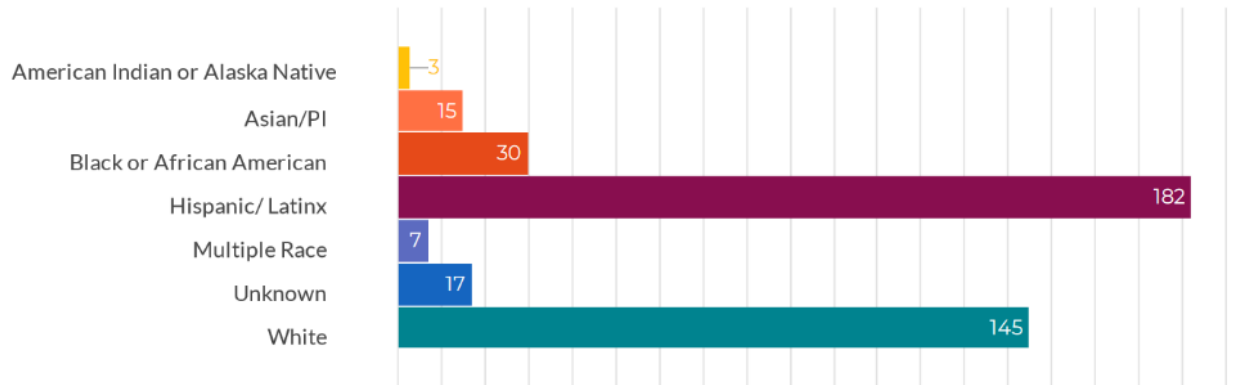
COVID-19 Deaths by Age Group

COVID-19 Deaths by Race/Ethnicity

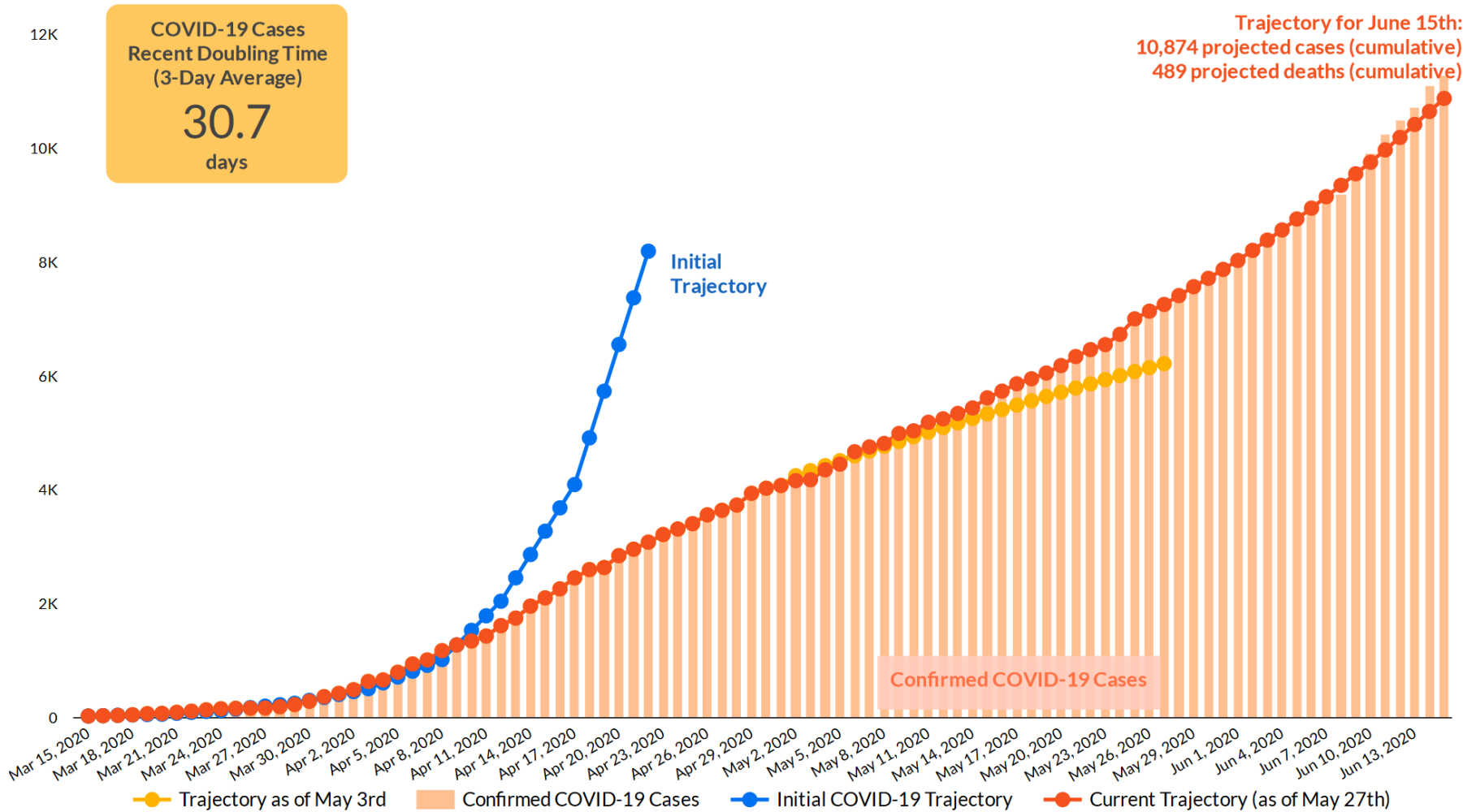

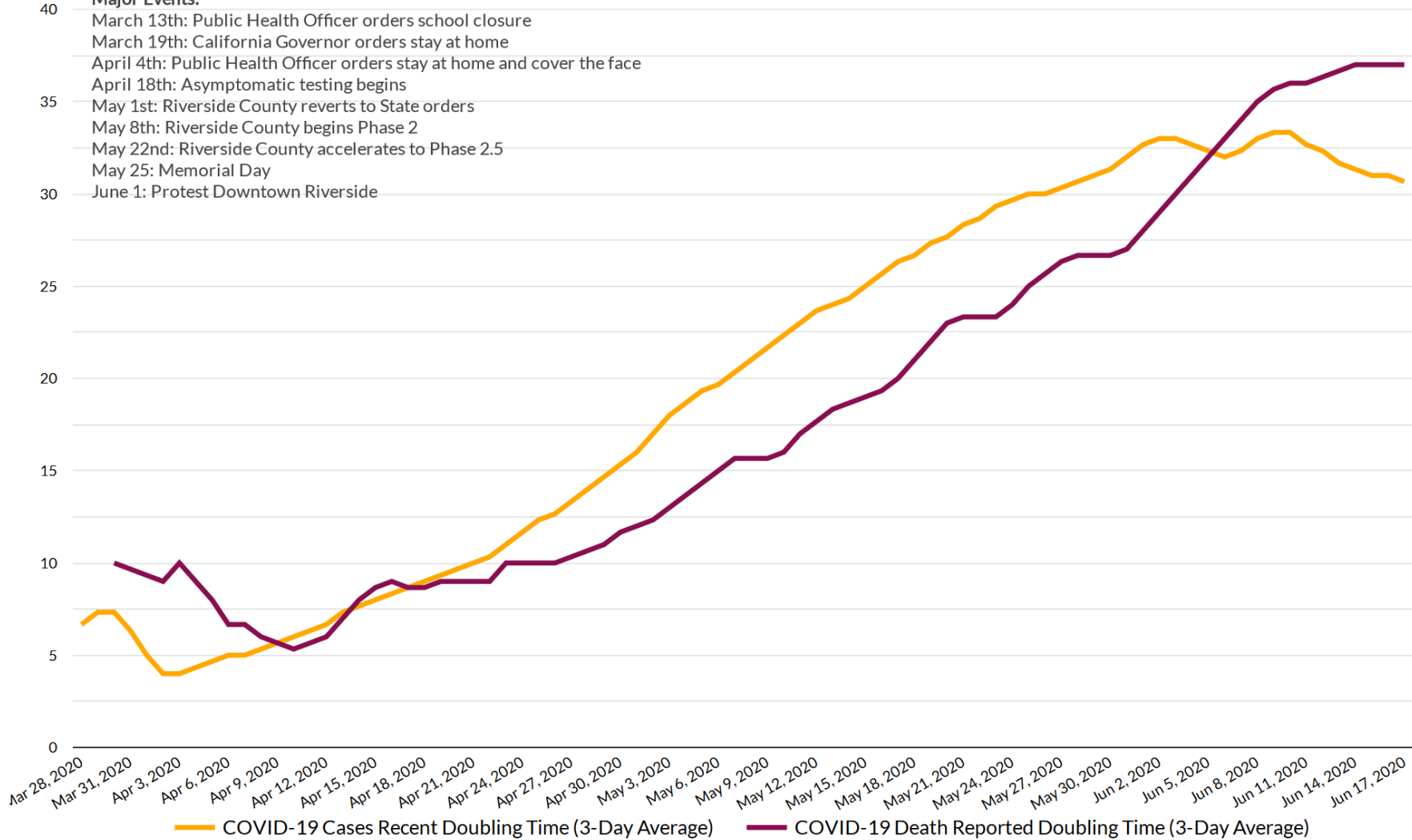

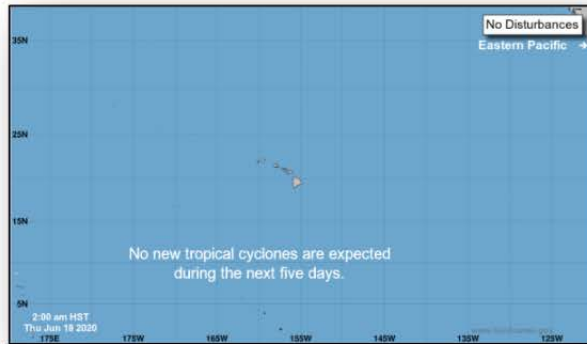

- Expected to form well S or SW of the southern coast of Mexico in a few of days
- Some slow development is possible through early next week while it moves W, offshore of Mexico
- Formation chance through 48 hours: Low (near 0%)
- Formation chance through 5 days: Low (20%)
