

Worldwide deaths per million people




Brazil surpasses 1.7 million coronavirus cases

- The number of coronavirus cases in Brazil surpassed 1.7 million on Wednesday after the country's health ministry recorded 44,571 new cases in the past 24 hours.
- The country's total number of confirmed cases is 1,713,160, according to the Brazil's health ministry.
- The ministry also reported 1,223 new Covid-19 fatalities, bringing the nationwide death toll to 67,964.
- This comes after Brazilian President Jair Bolsonaro announced Tuesday he tested positive for the virus, maintaining his less serious approach to the pandemic by taking his mask off during the news conference and telling young people, "if you are affected by the virus, rest assured that, for you, the possibility of something more serious is close to zero."

One-third of Americans missed their July housing payments due to Covid-19, survey says

- Thirty-two percent of Americans did not make a full, on-time housing payment in July due to the continued economic fallout of the coronavirus, according to online rental platform Apartment List.
- This is the fourth straight month of a "historically high" number of Americans unable to pay their full hosing bill, the survey released on Wednesday found, and up slightly from 30% in June. Missed payments continue to hit renters, young and low-income households, and residents of dense urban areas the hardest.
- And as eviction moratoriums and unemployment benefits expire across the country, Apartment List says that Americans worry
 missed payments could lead to them losing their homes.
- "As overdue bills pile up, there is growing concern that a wave of evictions and foreclosures will hit the housing market," the survey showed. "While eviction protections today vary dramatically from place to place, our survey shows widespread and growing concern about housing insecurity."

International students may need to leave US if their universities transition to online-only learning

- International students who are pursuing degrees in the United States will have to leave the country or risk deportation if their universities switch to online-only courses, Immigration and Customs Enforcement announced Monday.
- The move may affect thousands of foreign students who come to the United States to attend universities or participate in training programs, as well as non-academic or vocational studies.
- Universities nationwide are beginning to make the decision to transition to online courses as a result of the coronavirus pandemic. At Harvard, for example, all course instruction will be delivered online, including for students living on campus. For international students, that opens the door to them having to leave the US.
- In a news release Monday, ICE said that students who fall under certain visas "may not take a full online course load and remain
 in the United States," adding, "The U.S. Department of State will not issue visas to students enrolled in schools and/or programs
 that are fully online for the fall semester nor will U.S. Customs and Border Protection permit these students to enter the United
 States."

There are no ICU beds available in 42 Florida hospitals

- There are currently 42 Florida hospitals that are at zero capacity for intensive care unit beds.
- This is down from 56 hospitals reported on Tuesday, according to Florida's Agency for Healthcare Administration (AHCA).
- On Wednesday, 54 hospitals around the state were at 10% capacity or less, according to the AHCA dashboard.
- Boca Raton Hospital in Palm Beach County normally has 230 adult ICU beds, there are just 11 available; lowering their capacity to 4.56%, according to AHCA.
- Miami-Dade County has 992 adult ICU beds in its hospitals but currently 170 are available, 17.14% capacity, AHCA data shows.
- "The state has established a field hospital at the Miami Beach Convention Center with over 450 beds to allow for even greater capacity if necessary," the AHCA statement said.

- Mississippi Health Department Dr. Thomas Dobbs said the state is continuing to work on an outbreak that resulted in several legislators testing positive for coronavirus.
- "Thus far, we have identified 36 cases associated with the outbreak, 26 of whom are legislators," Dobbs said.
- More on this: Mississippi Gov. Tate Reeves has tested negative for Covid-19, his office announced on Tuesday, while the Lt. Gov. Delbert Hosemann and State House Speaker Philip Gunn have both tested positive.

37 football players and staff at University of North Carolina test positive for Covid-19

- The University of North Carolina has suspended the football program's voluntary workout program after 37 players and staff tested positive for Covid-19.
- The Orange County Health Department in North Carolina determined the number of results to be a cluster forcing the Tar Heels
 to halt activities. The school says it administered 429 tests to players, coaches and staff with roughly 12% returning positive for
 coronavirus.

Summer camp closes after Covid-19 outbreak in Arkansas

- Camp Ozark, a summer camp facility located in Mount Ida, Arkansas, has temporarily closed down after an outbreak of Covid-19, according to Dr. Nate Smith, the state's cabinet secretary for the Department of Health.
- At the Kanakuk K-2 Camp in Lampe, Missouri, 82 campers, counselors and staff tested positive for Covid-19, according to a Facebook post by the Stone County Health Department.
- While 31 of the infected were tested onsite, many of the other cases were tested after they had returned to their homes. Just one positive case resides in Stone County, where the camp is located. The K-2 camp is for teenagers, aged 13-18, according to Kanakuk's website.
- "Camp Ozark shared the information that they had on out-of-state campers and a counselor. They took action. They initially sent campers home and some counselors home, and then, as they had additional cases, they made the decision on their own to go ahead and close down for now," Smith said. "We support that decision and we appreciate them partnering with us."
- Asked how the outbreak at the summer camp will inform his decision about reopening schools in the fall, Arkansas Gov. Asa
 Hutchinson said "it simply means that whenever we reconvene, we're going to have to adhere to those public health guidelines
 very strictly and not ignore, not that the summer camps did, but that we realize that when you have that congregation of people,
 it's going to be a challenging environment that you've got to work with."

White House effort to circumvent CDC's school-opening guidance undermines health and safety

• The Trump administration's efforts to pressure the US Centers for Disease Control and Prevention into revising school reopening guidelines, and threats to withhold funding from school districts that do not reopen, could have deadly consequences, said American Public Health Association Executive Director Georges C. Benjamin.

- In a statement released Thursday, Benjamin said the Trump administration's actions "wrongly makes educators, students and parents political pawns and could have deadly consequences during the COVID-19 pandemic."
- The CDC has recommended that schools reopen cautiously, calling for physical distancing, physical barriers and proper cleaning. On "Good Morning America" Thursday, CDC Director Dr. Robert Redfield said that the guidelines for reopening schools will not be revised, but that the agency will provide additional reference documents to help guide schools in their decisions.
- "The Trump administration has no justification for overruling science-backed information that the CDC has initiated in school opening plans," Benjamin added. "All of us want a red traffic light to turn green at an intersection, but we don't just drive through recklessly and risk our own lives and those of others."

Covid-19 hospitalizations in California are up 44%, governor says

- Coronavirus hospitalizations in California are up 44% over the past two weeks, Gov. Gavin Newsom said today in a news conference. That translates to about 6,100 patients.
- The number of patients in intensive care has climbed by 34% in the past 14 days.
- California has added 11,694 additional cases, but Newsom cautions that approximately 2,000 of those are from a backlog in Los Angeles County. This brings the total number of cases to nearly 290,000.

California governor says schools will reopen when the data shows it is safe to do so

- California schools will reopen when the data shows it is safe to do so, according to California Gov. Gavin Newsom
- "I'm not worried about the latest tweets," he said, in a thinly veiled reference to President Trump.
- "We need to address safely reopening schools. That to me is non-negotiable," the governor said at a news conference.
- Reopening schools will be based on local conditions in the state, but Newsom added that "we must insist upon learning at the beginning of the school year."

- "Given our current data and the ongoing community transmission of this deadly virus, it's prudent that school districts prepare a
 distance learning back-up plan that is ready to be implemented in the event that our data shows us this is the safest path
 forward," the Los Angeles County Department of Public Health said in a statement to CNN.
- Anticipating that schools will continue to be a topic of conversation, Newsom implored the public that reopening is contingent on behavior.
- "We can just roll over and accept the spread and transmission with behaviors that have led to this," Newsom said. "Or we can do more to practice personal responsibilities with face coverings and masks and physical distancing that will mitigate the spread."

Pomona College will not welcome back students in the fall

- Pomona College, located in Los Angeles County, California, will not be welcoming back students for the fall semester and will continue remote learning, the president of the college announced in a letter Wednesday.
- "This situation is not what we hoped for," Pomona President G. Gabrielle Starr said. "On-campus, in-person education is central to our liberal arts mission. The reality is that if we had brought students back for fall, it would be under such restricted conditions that campus life would bear little resemblance to the community we cherish: No public gatherings or performances, no face-to-face meetings between students and professors, no orientation trips—the list of 'no's' would be extensive."
- The college said that the school would be reaching out to international students in the coming days with updates on how they planned to address the guidance issued by Immigration and Customs Enforcement earlier this week.
- In a news release Monday, ICE said that students who fall under certain visas "may not take a full online course load and remain in the United States," adding, "The U.S. Department of State will not issue visas to students enrolled in schools and/or programs that are fully online for the fall semester nor will U.S. Customs and Border Protection permit these students to enter the United States."

First California theme park pushes reopening date to August

- California theme parks that have pushed proposed reopening dates from April and May to June and July amid months-long coronavirus closures have now reached another humbling milestone: August.
- Legoland California has announced that the San Diego theme park won't reopen before Aug. 1 due to local regulations tied to the COVID-19 pandemic.
- "Considering the constantly changing coronavirus situation and the recent announcement by the San Diego County Board of Supervisors, Legoland California will not reopen prior to August 1, 2020," Legoland officials said in a statement. "The board announced there will be no reopenings approved prior to that date."
- San Diego County won't consider further reopenings of any additional businesses before Aug. 1 to help slow the spread of COVID-19.

L.A. County records highest daily coronavirus death toll in a month

• Los Angeles County on Wednesday recorded its worst daily coronavirus death toll in at least a month, which may be the result of increased disease transmission that likely began around Memorial Day.

- Officials with the Los Angeles County Department of Public Health reported 60 new coronavirus-related deaths Wednesday, and Long Beach — which has its own health officer — reported one new death. The combined total of 61 cases is the highest single-day death toll since June 2, when 62 deaths were reported across L.A. County, according to the <u>Los Angeles Times' California coronavirus tracker</u>.
- "This is more people hospitalized each day for COVID-19 than really at any other point in the pandemic," Ferrer said. "We are worried, given the higher rates of hospitalizations, that deaths may go back up."
- Experts say it can take three to four weeks after exposure to the virus for infected people to become sick enough to be hospitalized, and four to five weeks after exposure for patients to die from the disease.

Coronavirus Spike Threatens LA School Reopenings

- By week's end, Los Angeles County schools could have a series of health protocols to serve as guidelines for reopening schools, county officials announced Wednesday.
- The announcement follows a head-spinning series developments at the federal level this week after the Centers for Disease Control and Prevention issued coronavirus protocols for schools, only to provoke the ire of President Donald Trump. After Trump declared the guidelines too strict, Vice President Mike Pence announced plans to loosen them.
- The nation's largest school districts, Los Angeles and New York, have warned that the upcoming school year is likely to involve a
 measure of distance learning. According to the Los Angeles Times, Los Angeles County Public Health Director Barbara Ferrer
 told a conference call of school superintendents that the current surge in new COVID-19 cases threatens the reopening of
 schools.
- Ferrer insisted she will not get mired in the mounting political debate of whether campuses should be required to open this fall.
- "The Plan B has always been a plan if there was way too much community transmission; it may, in fact, mean there has to be a longer period of time for there to be more virtual learning as opposed to on-campus learning," Ferrer said. "It's really important that when we have so much community transmission to understand the impact is far-reaching ... on the reopening not only of school campuses but other sectors that still haven't reopened. ... "You absolutely would not want to open a sector when you thought the result of a reopening could be an explosion of outbreaks within that sector," she said. "So we're going to continue to be mindful of what our data is telling us."



RIVERSIDE COUNTY DAILY COVID-19 CASES






Tropical Outlook – Central Pacific






Severe Weather Outlook
