Figure 2. Number of confirmed\* COVID-19 cases reported in the last seven days by country, territory or area, 30 July to 5 August \*\*





Figure 3. Number of confirmed COVID-19 cases, by date of report and WHO region, 30 December through 5 August\*\*









## More than half of India's Mumbai slum residents may have been infected with Covid-19, study suggests

- More than half of residents living in Mumbai's crowded slums may have contracted coronavirus and are likely being infected at a
  much higher rate than those not living in slum areas, a new study has found.
- The study released Tuesday raises questions over the level of testing in India, which has the third highest number of confirmed cases in the world after the United States and Brazil.
- On Wednesday, India reported it had crossed 1.5 million reported coronavirus cases after more than half a million infections were recorded in just 12 days. It took nearly six months for India to reach its first 1 million confirmed cases.
- The study -- a collaboration between local authorities and medical institutions -- found that 57% of the samples collected from slum
  residents tested positive for coronavirus antibodies, while only 16% of those living outside of slums tested positive, according to a
  news release Tuesday.
- The researchers used antibody tests -- which are used to test whether a person had coronavirus in the past -- to analyze more than 6,900 random samples collected from participants living in Mumbai in the first half of July.

## India's home affairs minister tests positive for coronavirus

- One of India's most senior officials tested positive for the coronavirus and another minister died of the virus on Sunday, marking the end of India's deadliest week of the pandemic so far.
- Minister of Home Affairs Amit Shah announced on Twitter that he was tested after developing symptoms of Covid-19, and has been admitted to a Delhi hospital.
- "I got the test done and was found positive," the 55-year-old minister said, adding that he asked those who have been in contact with him in the past few days to isolate and be tested.

## Florida shop gets more threats over mask rule, but also outpouring of support

- MELBOURNE, Fla. In March, as Florida rolled back its COVID-19 social distancing restrictions, Karen and Friends Beads reopened in Melbourne, and Mendy White posted a note on the door saying masks were required inside her store. A man she asked to wear one flashed a gun at her before he and his wife left the store in anger.
- Since first reported by Florida Today and then USA TODAY, calls both offering money and making threats have poured into the shop. White, who initially said she didn't want her mask policy to drag politics into her business, found herself thrust more publicly into controversy.

## Coronavirus pandemic reshapes and reduces back-to-school spending

 For some back-to-school shopping always meant heading to Target and the local mall and dropping about \$500 on each child of them for trendy outfits. But not this year.

- The Charlotte, North Carolina, woman cut her spending on clothing in half for her 10-year-old and 14-year-old and instead spent
  more on masks and other supplies as a surge in coronavirus cases forced her school district to extend online learning through the
  fall. "The kids always looked forward to getting something new," "It didn't make any sense to buy any extra clothes that won't be
  worn."
- As the pandemic drags into the new school year, it is wreaking havoc on reopening plans and the back-to-school shopping season, the second most important period for retailers behind the holidays.
- Parents are buying less dressy clothing and more basics for their kids, while stepping up purchases of masks and other protective equipment as well as electronics. They're also holding back on spending amid uncertainty over what the school year will look like. The back-to-school season typically kicks off in mid-July and peaks in mid-August. This year, experts predict the peak will hit in late August and spill into most of September.
- "We are definitely seeing a delay," said Jill Renslow, senior vice president of the Bloomington, Minnesota-based Mall of America, which reopened in mid-June with social-distancing protocols. "People just don't know what they need."

## **Photo Of Paulding Students Packed Into Hallway Goes Viral**

- DALLAS, GA Photos of maskless students packed into a hallway at North Paulding High School sparked nationwide outrage Tuesday after they went viral.
- "There is no question that the photo does not look good," Paulding superintendent Brian Otott wrote in an email Tuesday to parents. "I can understand if your first reaction was one of concern."
- WSB-TV in Atlanta confirmed that the photo was taken at dismissal time Monday by a 10th grader. Students are crowded next to each other, and most aren't wearing masks.
- Otott wrote in the letter that the photo was being taken out of context to "criticize our school reopening efforts.
- "Under the COVID-19 protocols we have adopted, class changes that look like this may happen, especially at a high school with more than 2,000 students," he wrote.
- Still, Otott said he won't mandate masks.
- "Wearing a mask is a personal choice and there is no practical way to enforce a mandate to wear them," Otott wrote. "What we will
  do is continue to strongly encourage all students and staff to wear masks."

## **Doctors To Kemp: Mandate Masks**

- A letter to Gov. Brian Kemp signed by more than 2,100 Georgia health care professionals is urging more-aggressive measures including mandatory masks to slow the spread of COVID-19.
- "We firmly believe that if policy decisions are made based on science, economic benefits will follow," the letter read. "Now is the time
  to update policies to align with current science."



- The letter, copied also to Public Health Commissioner Dr. Kathleen Toomey, was released Friday to news media.
- After pointing out Georgia's rapidly increasing number of new COVID-19 cases and deaths along with the shrinking number of intensive care beds in hospitals the letter recommends:
  - Mandate temporarily that cloth face masks be worn outside the home.
  - Allow localities to implement stricter measures.
  - Where the seven-day average of positive coronavirus tests is greater than 10 percent, close bars and gyms, require strict social distancing in restaurants and limit gatherings to 10 or fewer people

## California teachers union warns that reopening campuses now would be 'reckless'

- As details for California elementary schools seeking to return with in-person instruction amid the coronavirus pandemic were released, one of the state's two powerful teachers unions warned that reopening campuses would be "reckless."
- It was not immediately clear how many public and private schools might apply for waivers to reopen elementary schools, but the idea of using classrooms in counties with increasing case numbers is misguided, said Jeff Freitas, president of the California Federation of Teachers, which represents 120,000 education employees.
- "We think that's dangerous and compounds the effects of spreading the virus," said Freitas. He noted that last Friday, California reported 215 deaths, its highest daily toll. "We broke the record for the most number of deaths just a few days ago. And now we're talking about waivers for reopening schools?"
- Rules announced earlier this month by the Gov. Newsom all but ensure the vast majority of the state's K-12 schools serving 6.7
  million students won't reopen classrooms when the academic year starts. Newsom stipulated that public and private schools in
  counties on a state monitoring list for rising coronavirus infections and hospitalizations can't hold classroom instruction until their
  county is off the list for 14 days.
- There are 38 counties representing more than 90% of the state's population on the list.
- The waiver application, released Monday by the state Department of Public Health, applies to kindergarten through sixth-grade schools seeking to reopen in the 38 counties. It recommends that local health officials not even consider waivers in counties with the highest rates of coronavirus infection more than 200 cases of COVID-19 per 100,000 people over two weeks. That's the case in 14 counties, including Los Angeles, Riverside and San Bernardino, with several others just below the threshold.
- The waivers only apply for kindergarten to sixth grade because health officials say those students are less likely than older children to become infected or transmit coronavirus. For most people, the new coronavirus causes mild or moderate symptoms, such as fever and cough that clear up in two to three weeks. For some, especially older adults and people with existing health problems, it can cause more severe illness, including pneumonia and death.

## With classes set to resume in 2 weeks, LAUSD releases plans for start of new school year

- With instruction set to resume on Aug. 18, the nation's second-largest district will continue to hold classes online indefinitely amid the coronavirus pandemic, extending the longest closure in recent history.
- "The health and safety of all in the school community is not something we can compromise on," LAUSD Supt. Austin Beutner emphasized at a news conference Monday.
- The district's objectives, he said, are to balance the educational needs of students with the impact the virus is having on working families, while simultaneously ensuring everyone in the school's community is protected.
- That includes not just meeting the educational needs of students, but also keeping children and their families safe by providing them with nutrition, mental health resources and child care.
- To start the 2020-2021 academic year, students will have a regular schedule with daily, live engagement when the semester starts online, according to LAUSD's plan. Attendance will now be taken each day, as opposed to spring and summer distance learning sessions, when it was tracked by log-ins.
- LAUSD is addressing the digital divide by ensuring all students have proper devices, internet and instruction materials. Accordingly, the district will work to repair or replace broken devices, and a phone hotline will be available for technological issues.
- While school is set to resume on Aug. 18, the first two days will be set aside for orientation and the distribution of devices, textbooks and instructional materials.
- California has laid out a set of guidelines for school's to resume classes, allowing only those in counties that have been off the state's COVID-19 monitoring list for two consecutive weeks to hold in-person instruction.

## Wildomar charter schools seeks to be classified as day care to reopen classrooms

- A Wildomar charter school is forging ahead with plans to resume in-person learning despite orders from Gov. Gavin Newsom that schools in counties on the state COVID-19 watch list can't reopen without a waiver.
- "We've got to do whatever we can for our children," said Sycamore Academy Charter School executive director Barbara Hale.
  "That's what this is about."
- In an email Hale sent out to school staff on July 22, in which she wrote that after reviewing the governor's updates she doesn't believe there is any official mandate to close schools. And Hale believes that by applying for a child-care license, she will still be able to allow the school to be open to students as a day care.
- "The children need the school," said Hale. "They need to be with mandated reporters. They need to be with people trained to teach, trained to do occupational therapy, trained to do speech services.
- Hale said there are three options for students to continue their studies when classes resume at Sycamore Academy Charter School in Wildomar on Aug. 24.
- For parents who are uncomfortable sending their children back to class, they can continue distanced learning from home by using Chromebooks provided by the school. Another option would be to use home study packets, and then spend up to 90 minutes per week of remote time with a teacher. A third option would be for students to return to the classroom that would be operating as a day care.

- Hale said each classroom would be limited to 14 students. "We've bought extra sinks to encourage hand-washing often," Hale said.
   "We have hand sanitizer; we have face masks and face shields for every staff member and every student."
- Riverside County Health Officer Dr. Cameron Kaiser comment with the following statement: "What the school is doing is illegal, and while it is a viewpoint some schools in Riverside County have embraced, it has no basis in jurisprudence. "The opinion of our county counsel is that the state's guidance has the full force and effect of law, is mandatory, and applies to public and private schools equally. ## 2 Studies Suggest Young Children May Be Major Drivers of the Coronavirus Pandemic

- Two new studies one done in Chicago and the other in Trento, Italy have found that although children under five years of age are less likely to become ill from COVID-19, they transmit the coronavirus more efficiently than adults
- Specifically, the Chicago study found that children five years or younger with mild to moderate COVID-19 symptoms have 10 to 100 times as much SARS-CoV-2 in their nasal passages as older children and adults, reports Forbes. This means that these children can "potentially be important drivers of SARS-CoV-2 spread in the general population," according to the study's research letter, which was released last week by the JAMA Network.
- The study also found that children, ages five to 17 with mild or moderate coronavirus symptoms have as much virus in their nasopharynx as adults.



## 35% of Parents Won't Have Any Childcare if Schools Don't Reopen

- Results from a survey sent to American parents show they are anxious about the potential impact on academics, health and family finances if schools do not reopen in the fall amid the coronavirus pandemic.
- The survey of more than 2,000 U.S. adults was conducted online by Propeller Insights on behalf of Healthline, a digital health information site, from June 16-19, 2020. It looked at how parents will cope with virtual learning, work and the cost of additional childcare if schools stay closed, and the stress of unknown health risks if they do reopen, according to Healthline.
- A third of parents said they are still waiting to hear what the back-to-school plan is for their child's school. Of those who have heard the plan, 33% don't trust it will work. Only 10% of parents reported feeling comfortable sending their kids back to school. The remainder are waiting for:

- A vaccine (37%)
- Their child's school to meet CDC guidelines (36%)
- America to enter Phase 4 of reopening (34%)
- Their local school district to determine if it will reopen (32%)
- Another 23% said they don't plan on sending their child back to school in the foreseeable future.
- Further findings include:
  - 54% said childcare will be a financial burden if school don't reopen
  - 35% won't have any childcare
  - 48% of parents making under \$50,000 a year won't have childcare
  - 26% of parents who make \$50,000-\$75,000 a year will be unable to return to work
  - 60% said facilitating their child's remote learning at home adds significant stress to their day



- 1. They will fall behind academically (39%)
- 2. They will be socially isolated (39%)
- 3. They will eat too much junk food (35%)
- 4. They will not get enough exercise (32%)
- 5. They will be depressed (28%) or scared (27%)

## Scam Alert: Watch Out For Fake Coronavirus Contact Tracing Calls

- Federal and local officials are warning people to be on high alert and watch out for scams during the coronavirus pandemic, including suspicious phone calls from some scammers posing to be contact tracers.
- Locals say callers pretending to be a contact tracer have asked for social security numbers and bank account information. A contact tracer will only ask for your name and date of birth, officials said.



- "Although the Los Angeles County Department of Public Health is doing contact tracing
  to stop the spread of the novel coronavirus, they will never ask you for Social Security
  numbers, financial information, payment, or anything about your immigration status,"
  the city of Santa Monica announced in a news release.
- Health departments use contact tracing to prevent the spread of infectious disease and it involves identifying people who have been exposed, which are identified as contacts, or people who have the disease, which are identified as cases.
- "Legitimate contact tracers will reach out to individuals who test positive for COVID-19, and their recent contacts," officials said. "They will ask for your name and date of birth, and information about anyone with whom you have been in close contact."
- Here's what to do if you receive a call, text or email from someone who identifies as a contact tracer:
  - Never give callers your Social Security number, bank account number, immigration status, or other similar personal financial information, or make any kind of payment to anyone representing themselves as a contact tracer.
  - Beware of suspicious links and attachments in emails or texts.
  - Remember that scammers can spoof phone numbers and email addresses to make it look like they are legitimate.
  - Do not click on links in ads or social media posts about contact tracing.
  - Do respond to legitimate contact tracers to help stop the spread of the novel coronavirus.


## A Harvard-trained psychiatrist is on Twitch helping gamers with their mental health

- Alok Kanojia, 37, is known as "Dr. K" to his fans, 370,000 of whom tune into his monetized Twitch livestream "Healthy Gamer GG" where he discusses issues like online harassment, depression and self-criticism with popular gaming guest stars. He also runs a YouTube channel with the same name that's monetized through ads.
- "I got into streaming not to be a streamer," he said. "I wanted to meet the gaming community where they're at."
- Since Kanojia began streaming on Twitch in September, he has found himself in the zeitgeist of the gaming industry, fielding discussions on the #MeToo movement in games and on a recent streamer suicide.




