CA Open Data Portal is at least 24 Hours behind although a backlog of new case reports at the State level has ostensibly been cleared, some County dashboards still contain notes that indicate data are missing. \*California-Demographics.com made by Cubit - a demographic data provider & census.gov

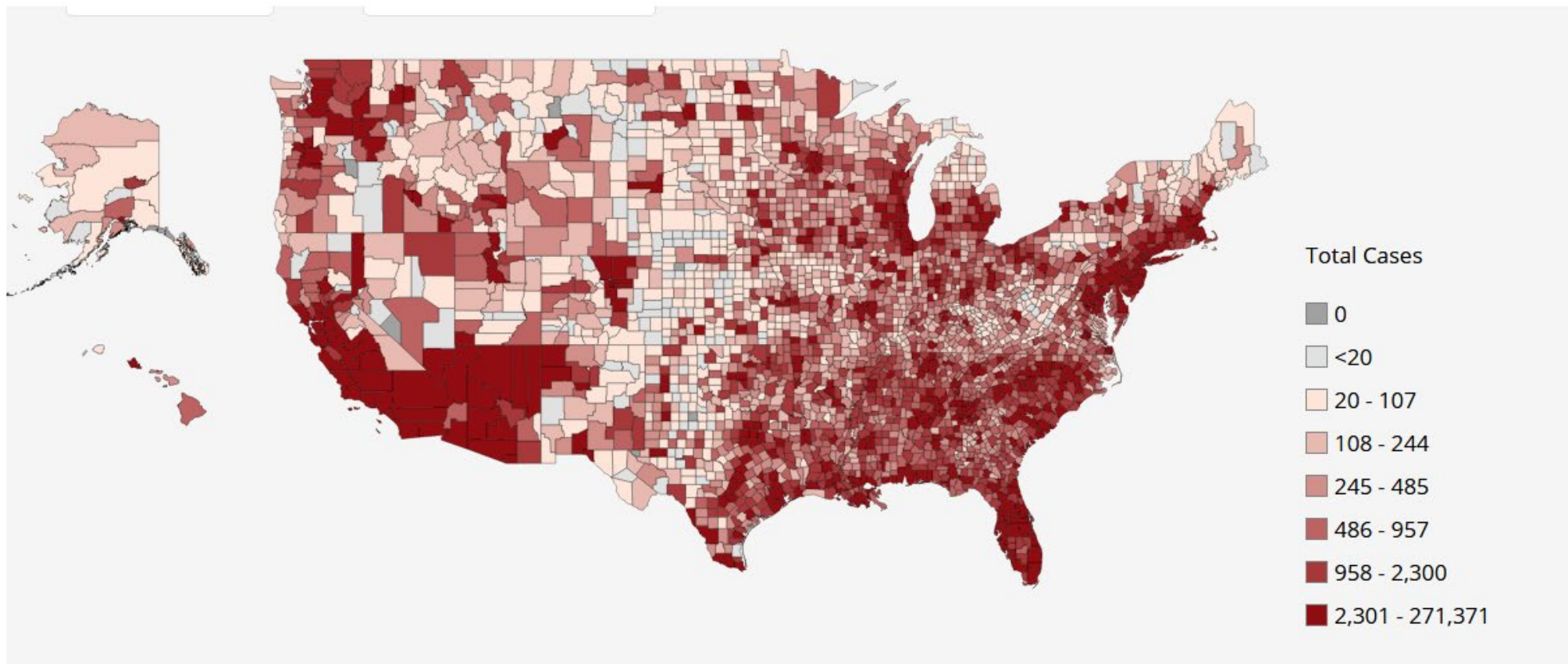

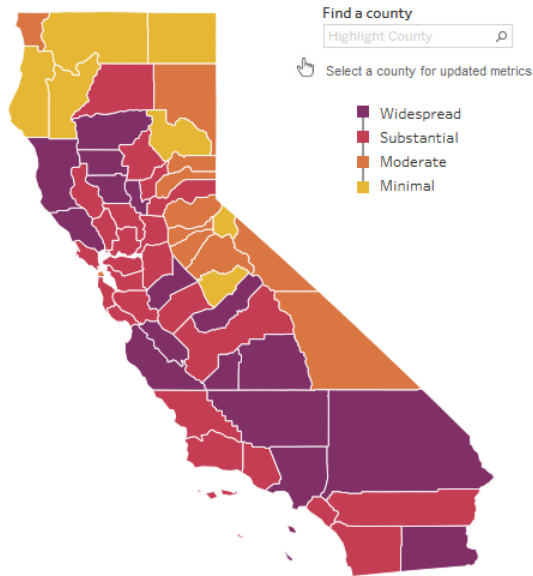

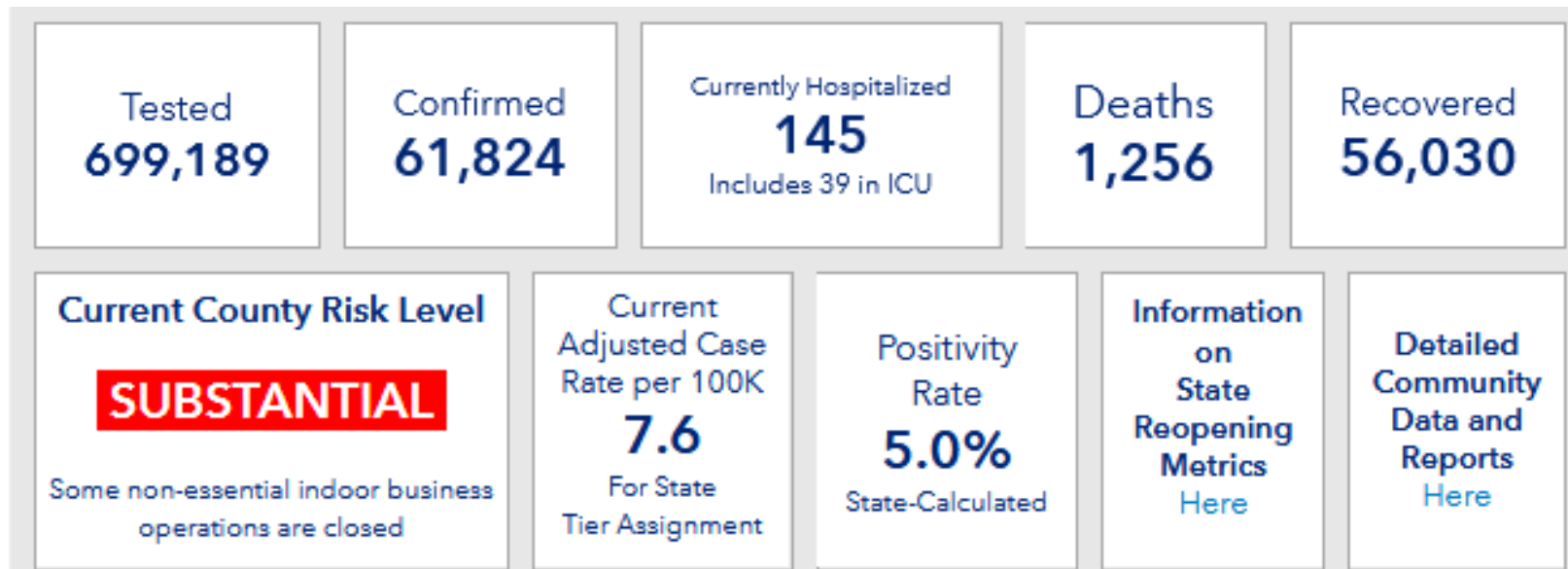
