### **Coronavirus strain homegrown in California, apparently more contagious, may be partly to blame for surge**

- Two independent research groups said they stumbled upon the new strain while looking for signs that a highly transmissible variant from the United Kingdom had established itself here. Instead, they found a new branch of the virus' family tree — one whose sudden rise and distinctive mutations have made it a prime suspect in California's vicious holiday surge.
- As they pored over genetic sequencing data in late December and early January, the two teams saw evidence of the new strain's prolific spread leap off their spreadsheets. Though focused on different regions of the state, they uncovered trends that were both remarkably similar and deeply worrying.
- Researchers at Cedars-Sinai Medical Center in Los Angeles found that although the strain had been barely detectable in early October, it accounted for 24% of roughly 4,500 viral samples gathered throughout California in the last weeks of 2020.

### **White House Releases Weekly Coronavirus Reports For States**

- "We are now sharing previously hidden weekly COVID-19 state profile reports with the public," Shahpar tweeted.
- For the most part, the Trump administration had kept the weekly reports under wraps, sharing them with state governors but not with the general public. While some governors would share the reports at a state level, not all did.
- The reports often contained key county-level data as well as federal recommendations by health experts that, if enacted, could potentially curb the spread of coronavirus.
- The reason for keeping them hidden, according to a report by the nonprofit Center for Public Integrity, was to encourage states to lead their own response to the pandemic.

## **Blue Shield of California tasked with ramping up state's coronavirus vaccine delivery system**

- Health insurance giant Blue Shield of California will be the outside administrator tasked with ramping up coronavirus vaccinations, which to date has been slow, stilted and plagued by confusion, the state health agency said in a statement Wednesday.
- The contract with Blue Shield is still being finalized but its task is to “create, contract with and manage a statewide vaccine administration network” and to allocate doses directly to providers, which will include pharmacies, public and private health networks and hospitals, pop-up sites and community health centers with an eye toward equity, according to the statement.

## **San Diego Zoo gorillas close to full recovery weeks after testing positive for coronavirus**

- A troop of gorillas at San Diego Zoo Safari Park appears to be recovering from the coronavirus — including a 49-year-old silverback who received antibody therapy — in what is believed to be the first known cases among such primates.
- “We’re not seeing any of that lethargy. No coughing, no runny noses anymore,” the park’s executive director Lisa Peterson told [the San Diego Union-Tribune](#), adding that the animals’ fecal matter is no longer testing positive for the virus. “It feels to us like we’ve turned the corner.”

## **L.A. County reports 8 new cases of rare inflammatory syndrome linked to COVID-19 in kids, bringing total to 62**

- Multisystem inflammatory syndrome, or MIS-C, is serious but relatively rare. In L.A. County, it has disproportionately affected Latino children. No further details about the eight new cases were available.
- Children are generally less vulnerable to the coronavirus than adults and usually remain asymptomatic. The inflammatory reaction that results in MIS-C usually develops two to four weeks after exposure to the virus.

## **Teachers need to be vaccinated before LAUSD schools can reopen: Supt. Beutner**

- Reopening Los Angeles campuses for students in kindergarten through 12th grade will require the vaccination of teachers and other staff, says L.A. schools Supt. Austin Beutner. The teachers union is going a step further, saying vaccinations alone would not be enough to operate schools safely until the community spread of COVID-19 is brought down.
- Their stances throw into question whether schools will be able to reopen this academic year as there is currently no firm date for inoculating teachers.
- “Vaccinations are a critical piece of the puzzle, and we’re all frustrated at the pace of the rollout despite everyone’s best efforts,” Beutner said in remarks broadcast Monday.

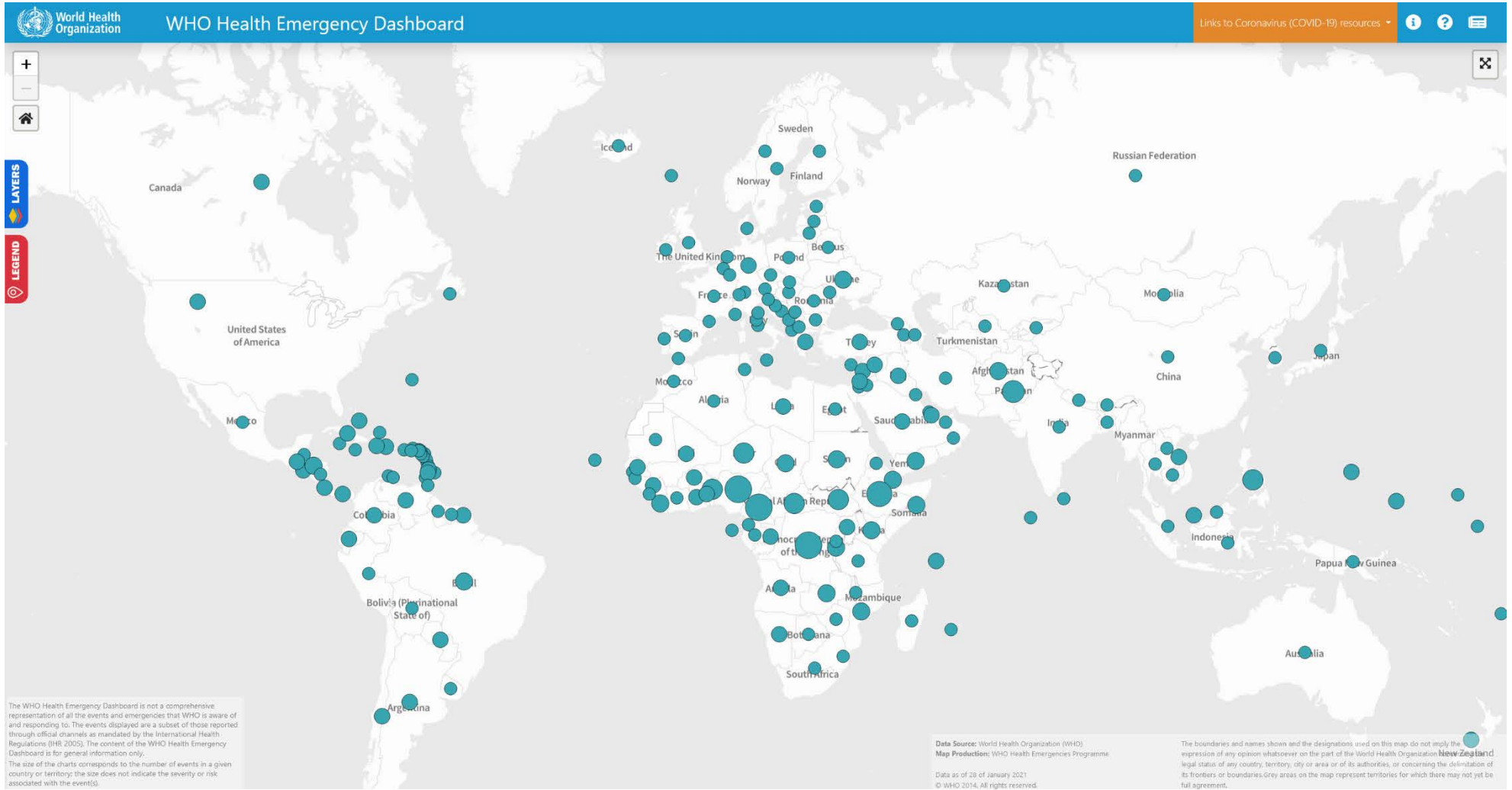

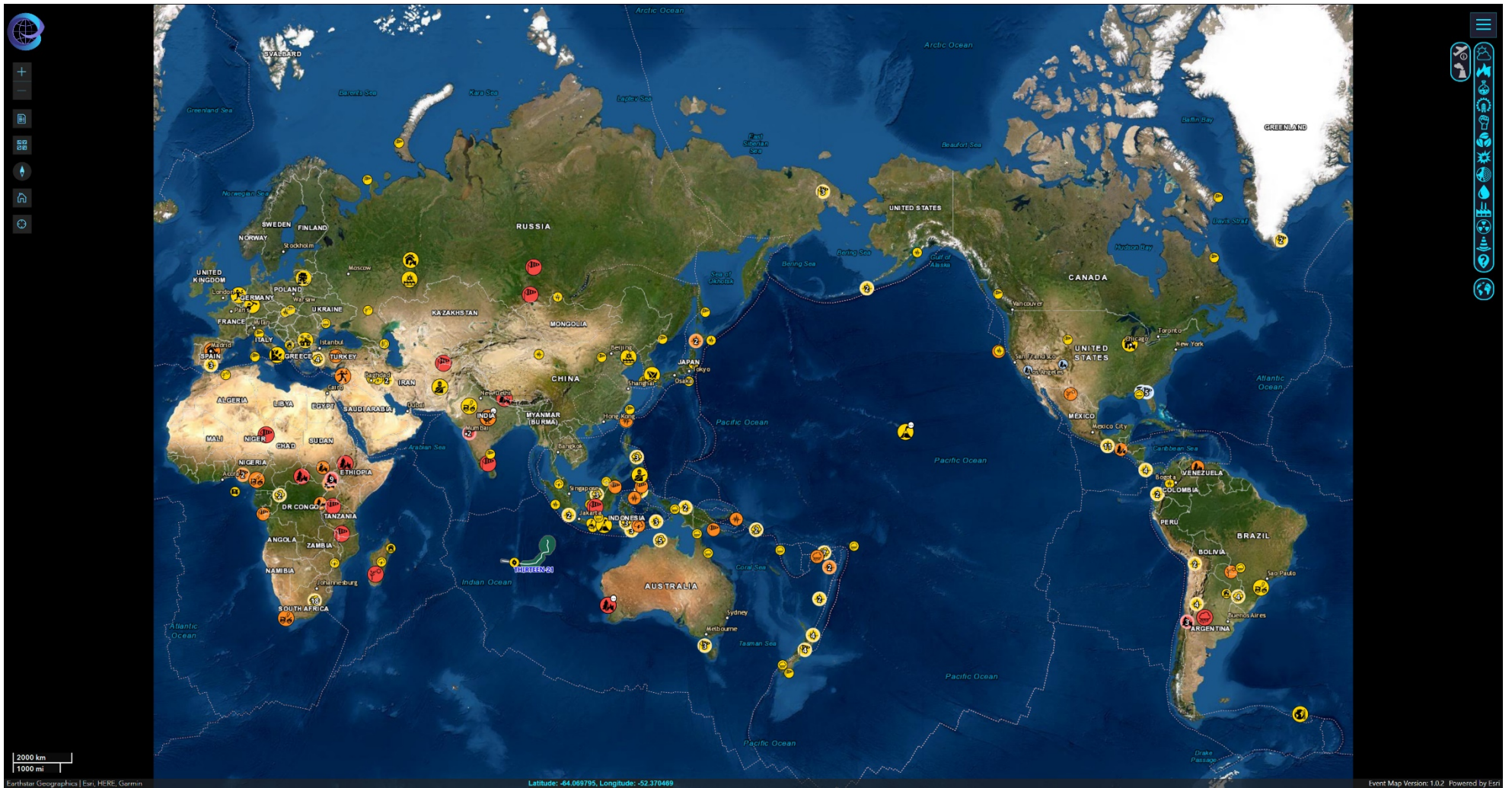

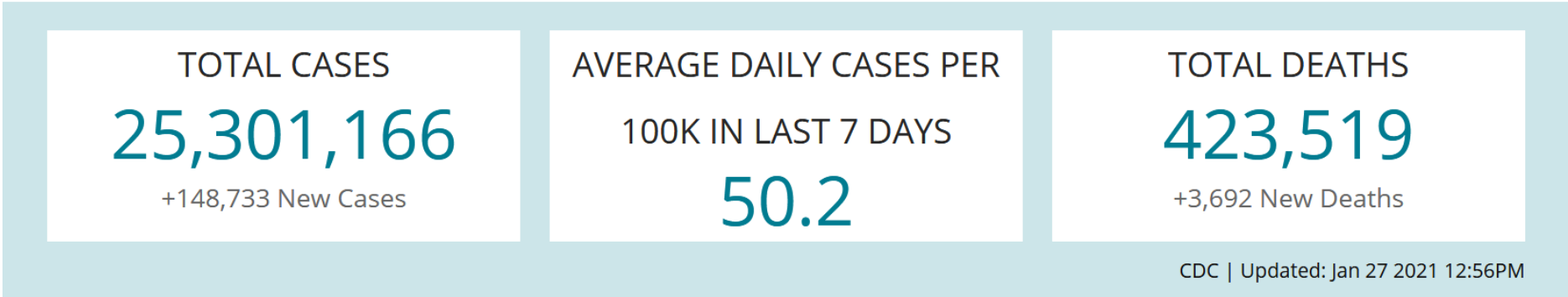

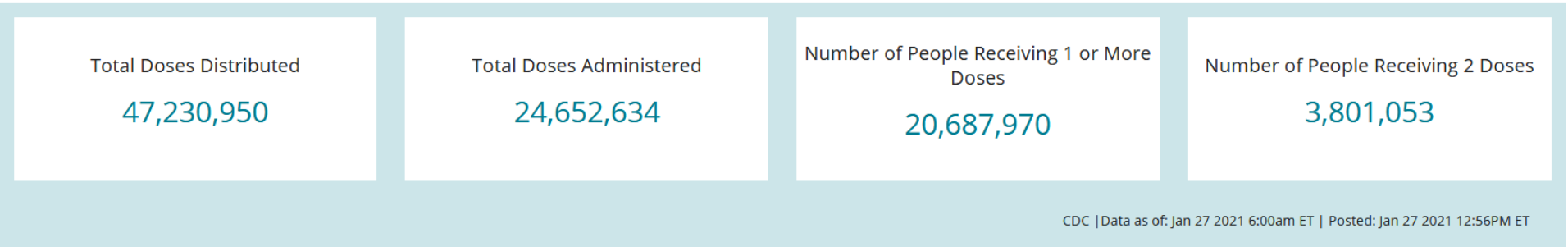
# United States COVID-19 Cases and Deaths by State

Reported to the CDC since January 21, 2020



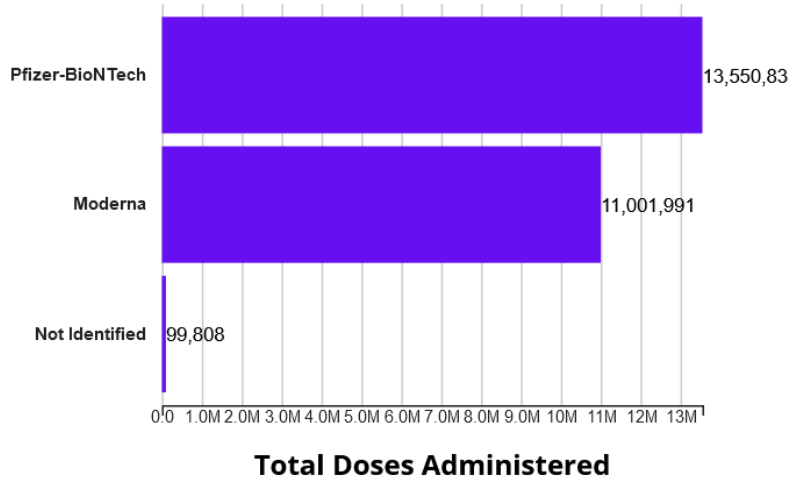

### U.S. COVID-19 Vaccine Administration by Vaccine Type



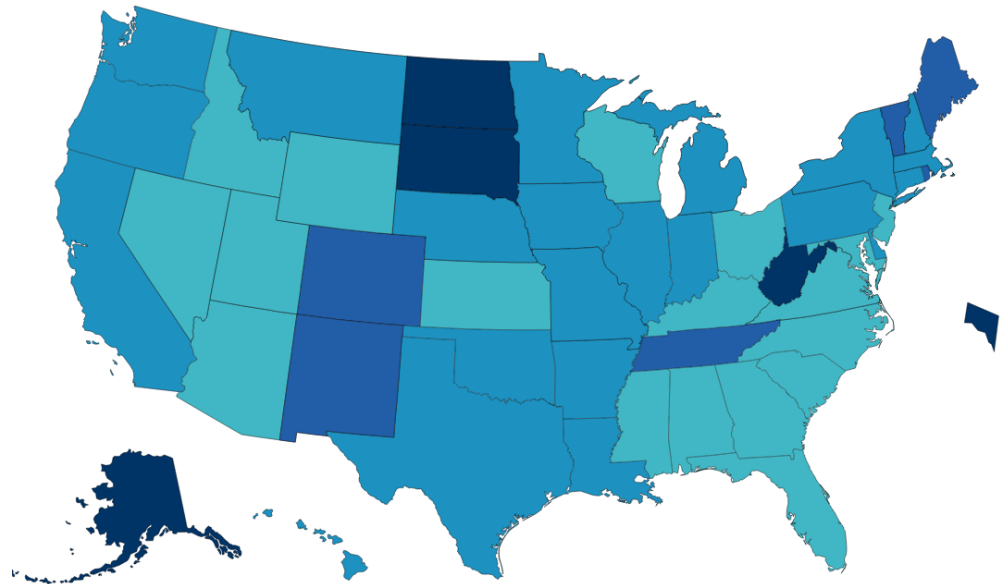

### Number of People Receiving 2 Doses Reported to the CDC by State/Territory and for Selected Federal Entities Per 100,000



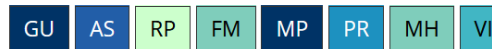
### Federal Pharmacy Partnership for Long-Term Care Program (Subset of Overall Numbers)

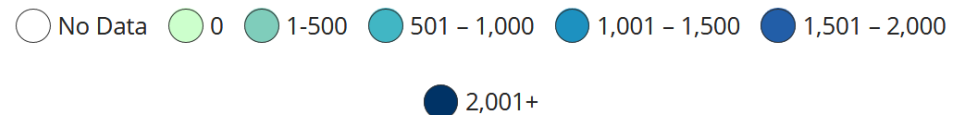

# FEMA's Role in COVID-19 Response

## Federal Funding to Accelerate State Vaccine Efforts

- FEMA, in accordance with President Biden's Jan. 21 Memorandum, will provide reimbursement to states, local, tribal and territorial governments and the District of Columbia for the use of their National Guard to respond to COVID-19 and other assistance, which may include support to vaccination distribution and administration, at a 100% cost share until Sept. 30, 2021.
- FEMA is supporting COVID-19 vaccine distribution by providing reimbursement to governments for costs associated with vaccine distribution and administration. Prior to the executive orders to expand vaccination efforts, FEMA obligated more than \$57.5 billion towards COVID-19 response efforts to support our state, tribal and territorial partners during this pandemic.
- As of Jan. 27, the Disaster Relief Fund balance is more than \$16.7 billion. These funds will support continued response to COVID-19, including expanded vaccination efforts across the country by providing financial assistance to governments and other eligible applicants for vaccination efforts as well as personal protective equipment, alternative care sites and durable medical equipment.
- Providing funding to states, tribes and territories is an Administration priority. After a request is submitted, FEMA expedites reimbursement for eligible emergency work projects to ensure resources are available to support vaccine distribution and administration.
- As of Jan. 27, FEMA obligated more than \$1.2 billion to states, territories, and tribes for expenses related to COVID-19 vaccination at 100% federal cost share:
  - \$43.3 million to Illinois.
  - \$219.5 million to Maryland.
  - \$216 million to New Jersey.
  - \$466.8 million to New York.
  - \$1.6 million to Pennsylvania.
  - \$76.6 million to Puerto Rico.
  - \$2.5 million to the U.S. Virgin Islands.
  - \$2.2 million to Virginia.
  - \$2.3 million to Washington, D.C.
  - \$1 million to West Virginia.
- These funds cover emergency protective measures to include:
  - Supplies and commodities needed to safely store and administer the vaccine.
  - Transportation support and reasonable, necessary security for refrigerated trucks and support for leasing space to store and/or administer vaccines including utilities, maintenance and security.
  - Medical and support staff including onsite infection control measures, personal protective equipment for staff, cloth face coverings for patients, temperature scanners, physical barriers and disinfection of the facility in accordance with CDC guidance.
  - Dissemination of public information and communication regarding vaccinations.
- The costs of purchasing the vaccine and support kits are not covered by these obligations and do not duplicate any HHS funding.
- The Coronavirus Response and Relief Supplemental Appropriations Act of 2021 appropriates \$2 billion to FEMA to provide financial assistance to individuals and households for COVID-19-related funeral expenses at a 100% federal cost.
  - The appropriation covers eligible funeral expenses incurred through Dec. 31, 2020.
  - FEMA is reviewing the legislation and evaluating potential options for implementation

## Federal Coordination to Identify and Fill Resource Gaps

- FEMA will work with the U.S. Department of Health and Human Services and other federal agencies to ensure a coordinated approach to using [Defense Production Act](#) authorities wherever necessary so private sector companies can increase vaccine supply and spur vaccine manufacturing.
- FEMA released "[FEMA COVID-19 Vaccination Planning FAQ](#)," a document to help assist governments with their vaccine distribution efforts and reimbursements for associated costs.

## FEMA and Other Federal Agencies Are Supporting and Establishing Vaccine Sites

- FEMA, through its National Response Coordination Center and 10 regional offices across the nation, will coordinate with other federal agencies to meet state, tribal and territory needs. FEMA is providing support to established vaccination locations, establish new community vaccination centers and support National Guard operations to expand access to vaccines.
- FEMA is committed to ensuring every American who wants a vaccine can get one. To reach underserved and rural communities, FEMA, in collaboration with federal partners, will coordinate efforts to establish and support fixed facilities and establishing pop-up or temporary vaccination sites and mobile vaccination clinics.
- FEMA has deployed staff to Arizona and Nevada to support state vaccination centers with personnel and technical assistance. Additional staff across the country are supporting virtually.
- As of Jan. 27, federally supported sites are operational across Arizona, Nevada, Texas and Washington.
- The U.S. National Guard Bureau is providing administrative and logistics support to vaccines sites in 22 states.

## Vaccine Guidance

- As of Jan. 26, CDC has administered more than 23.5 million vaccine doses. More than 44.3 million vaccine doses have been distributed to locations across the country.
- Because the supply of COVID-19 vaccine in the United States is limited, CDC is providing recommendations to federal, state, and local governments about [who should be vaccinated first](#). CDC's recommendations are based on those of the Advisory Committee on Immunization Practices, an independent panel of medical and health experts.
- FEMA is working with the [Ad Council to encourage hesitant or underrepresented Americans to get vaccinated](#). This research-driven public education campaign provides federal, non-profit, and medical stakeholders with insights and communications strategies to tailor communications to reach diverse audiences.
- Each state has its own plan for deciding which groups of people will be vaccinated first. You can contact your [state health department](#) for more information on its plan for COVID-19 vaccination.
- The vaccine is not a perfect fix. Everyone should continue to [practice other precautions](#) like wearing a mask, social distancing, handwashing and other hygiene measures until public health officials say otherwise.

# Debris Flows – California

## Situation:

Rain, heavy mountain snow and flash flooding are causing multiple minor debris flows across the CA burn scars; the largest is in the River Fire burn scar in Salinas, Monterey County. High Wind and Winter Storm Warnings and Flash Flood Watches are in effect.

## Lifeline Impacts: (RIX SPOTREPS Jan 27-28)

### Safety and Security:

- 25 buildings damaged (type of building unknown) due to River Fire burn scar debris flow
- Mandatory evacuations for Monterey and Santa Cruz counties
- Evacuation warnings for San Mateo County

### Food, Water, Shelter:

- 3 temporary evacuation sites open in Santa Cruz County

### Health and Medical:

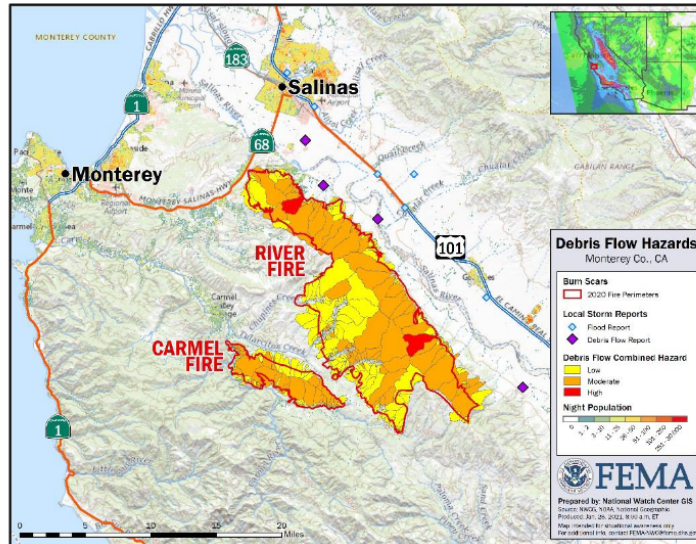
- 2 injuries due to River Fire burn scar debris flow

### Transportation:

- Portions of I-5 (Grapevine) closed due to snow
- Multiple minor debris flows impacting highways across the state

### Energy:

- Outages in affected counties are under 2% (as of 7:30 a.m. ET DOE Eagle-I)



## State / Local Response:

- CA EOC at Full Activation (COVID)
- Madera County declared a local state of emergency
- No request for FEMA assistance

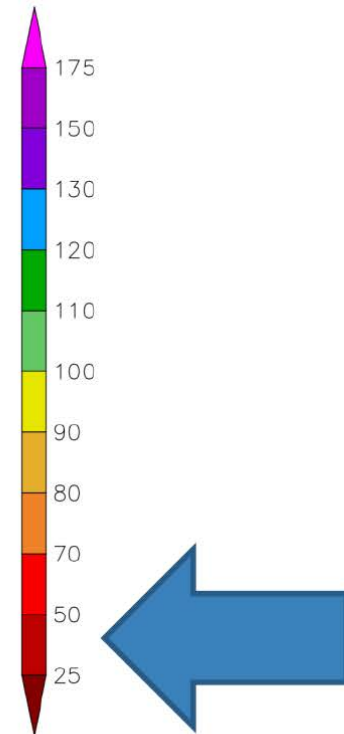
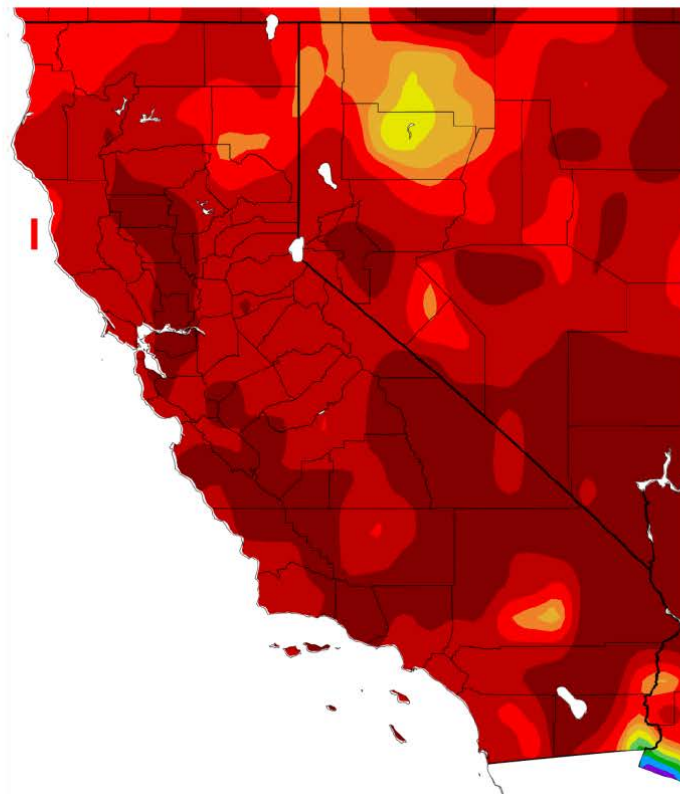

10/1/2020 – 1/25/2021



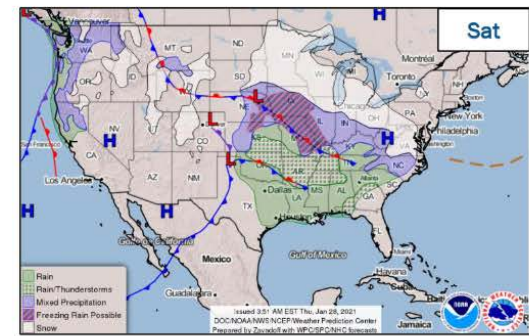
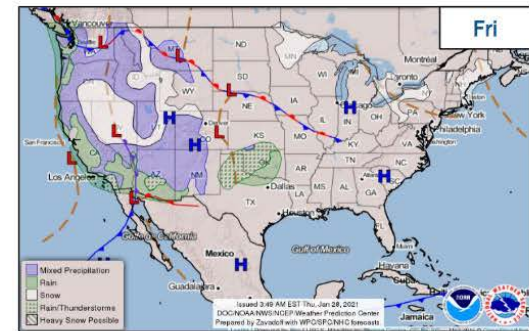
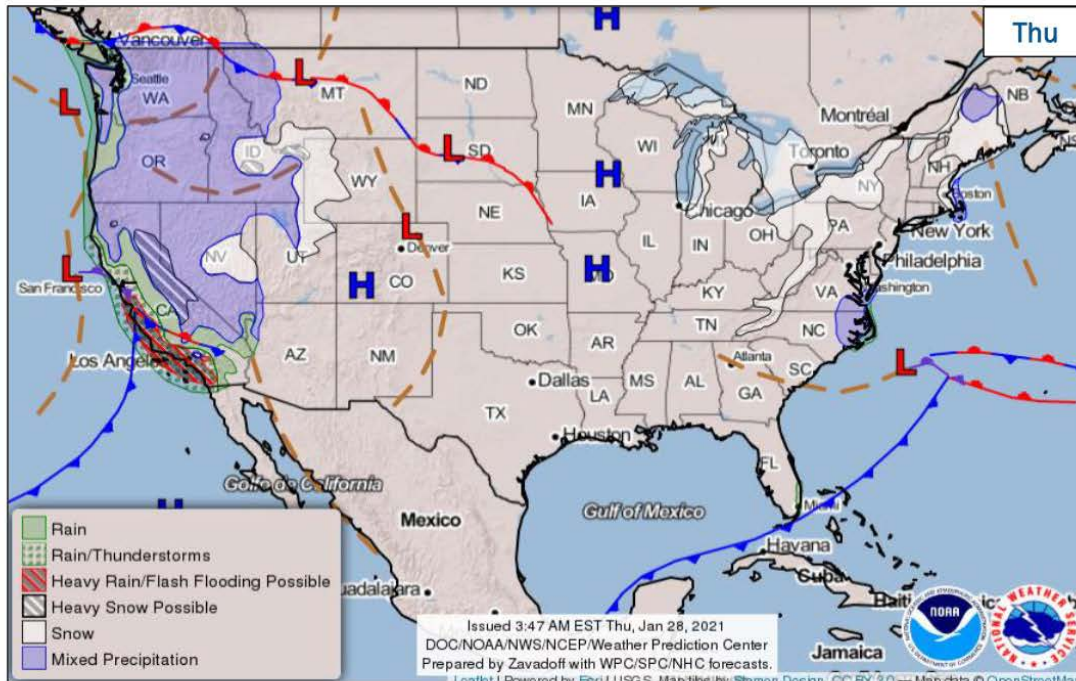
