Should Schools Reopen If Teachers Aren't Yet Vaccinated? CDC Will Soon Weigh In

- The federal government plans to release new guidance next week about how to safely reopen schools in the midst of the pandemic guidelines that could add new grist to a debate over whether schools should wait until teachers are vaccinated before requiring their return to the classroom.
- As the United States has struggled to get the spread of the coronavirus under control, many schools have turned to virtual learning. President Biden has pledged to get most students back to in-person learning by the end of April, but there are questions about how to do so safely.
- Some teachers' organizations have pushed back against plans to restart in-person learning, arguing that teachers should be vaccinated first and that other safety measures must be in place.
- Scientists at the Centers for Disease Control and Prevention scientists published an article last week in JAMA, the journal of the American Medical Association, that showed some schools were able to reopen safely by following safety precautions but the article included a disclaimer that the conclusions "do not necessarily represent the official position" of the CDC. https://www.npr.org/sections/coronavirus-live-updates/2021/02/05/964534341/should-schools-reopen-if-teachers-arent-yet-vaccinated-cdc-will-soon-weigh-in

Almost 1,600 Postal Workers in DC Region Tested Positive for COVID-19; 7 Have Died

- The I-Team found at least eight at Ward Place had tested positive by mid-October, according to the Postal Service. But some insiders worry the numbers might be even higher at mail facilities around the D.C. region.
- "We do not feel like we're getting good, accurate information on a timely basis," explained Arrion Brown with American Postal Workers, Local 140. He said one of his concerns is the time it takes for the agency to reveal when a positive case surfaces.
- Due to a shortage of Postal Service nurses who conduct the contact tracing. There was a 21% vacancy rate last year, according to a November audit from the Office of the Inspector General of the U.S. Postal Service. The report said "there was no national hiring strategy for these critical roles."
- "Being in the building a week after the person that was exposed in the building, that makes us vulnerable. We don't know who else that person had come in contact with and who they have come in contact with. So, it makes us feel anxious, vulnerable, angry, "said Brown.
- Unlike other federal agencies, including the Department of Veterans Affairs, the Federal Bureau of Prisons and the
 Transportation Security Administration, the USPS does not publicly post how many cases of COVID-19 it's had in each state
 or region. The News4 I-Team filed a Freedom of Information Act request and found the number of positive cases among
 postal employees has more than doubled since December, with almost 1,600 in D.C., Maryland and Virginia and at least
 seven deaths.

Coronavirus Precautions Likely Linked To Low U.S. Flu Cases

- ACROSS AMERICA Has the coronavirus essentially beaten the flu into submission?
- For the week ending Jan. 30, flu activity remains minimal in all states and U.S. territories. At this time last year, flu activity was high in 45 states, New York City and Puerto Rico.
- In the same week, 18,531 tests were processed at clinical laboratories throughout the United States, according to the CDC. Of those, only 25 were positive for influenza. At public health labs, 9,102 tests were processed, and only three were positive for influenza two were influenza A strains, while the other was positive for influenza B.
- So far this flu season, 1,499 tests or a meager 0.1 percent have come back positive for influenza, according to CDC data. https://patch.com/us/across-america/coronavirus-precautions-likely-tied-low-u-s-flu-cases

Battle To Beat Coronavirus Meets California's Anti-Vaxxers

- After an anti-vaxxer protest group briefly shut down the nation's largest coronavirus vaccination site at Dodger Stadium last week, the group vowed to disrupt more California vaccination sites in the coming days.
- The escalating tactics for disrupting vaccination efforts prompted the Los Angeles Police Department Chief Michel Moore to warn activists that they will be arrested if they block access to vaccination sites or intimidate workers and patients. It also inflamed familiar tensions between the anti-vaxxer movement epicentered in California and state lawmakers, who passed the strictest vaccination law in the nation in 2015.
