### The WHO's Chief Says It Was Premature To Rule Out A Lab Leak As The Pandemic's Origin

- The head of the World Health Organization acknowledged it was premature to rule out a potential link between the COVID-19 pandemic and a laboratory leak, and he said Thursday he is asking China to be more transparent as scientists search for the origins of the coronavirus.
- In a rare departure from his usual deference to powerful member countries, WHO Director-General Tedros Adhanom Ghebreyesus said getting access to raw data had been a challenge for the international team that traveled to China earlier this year to investigate the source of COVID-19. The first human cases were identified in the Chinese city of Wuhan.
- "I was a lab technician myself, I'm an immunologist, and I have worked in the lab, and lab accidents happen," Tedros said. "It's common."
- Tedros said that "checking what happened, especially in our labs, is important" to nailing down if the pandemic had any laboratory links. "We need information, direct information on what the situation of this lab was before and at the start of the pandemic," the WHO chief said, adding that China's cooperation was critical. "If we get full information, we can exclude (the lab connection)."

### Southeast Asian Countries Struggle To Contain A Devastating Third Wave Of COVID-19

- Southeast Asian countries such as Vietnam, Laos, and Thailand had avoided such largescale outbreaks previously. Now, they're struggling to contain fresh outbreaks, even as Indonesia and Myanmar are battling low vaccination rates, limited oxygen supplies and overcrowded hospitals. Health care experts say health care systems in both countries are on the brink of collapse.
- As of Sunday, <u>Indonesia reported</u> 73,582 deaths from COVID-19 and more than 2.8 million confirmed cases since the pandemic begain. For much of last week the country recorded a steady rise in infections, <u>surpassing India</u> and Brazil as the world's leader in new infection rates.

#### The Pandemic Has Worsened Childhood Vaccination Rates Around The World

- Nearly 23 million children around the world missed out on routine childhood vaccinations last year due to service disruptions from the pandemic, the World Health Organization and UNICEF report.
- India represented the largest increase in children not receiving their first diphtheria, tetanus and pertussis (DTP) vaccine from 2019 to 2020. In 2020, India reported more than 3 million children didn't receive their first DTP vaccine, up from the 1.4 million children who didn't get the shot in 2019, according to the data. And the trend remains a serious problem around the world.
- Global health officials have seen worrying signs that efforts to immunize children against preventable illnesses were failing even before the pandemic. In 2018, more than 140,000 people died from measles during a surge in cases around the world among young children who were not vaccinated against the illness. https://www.npr.org/2021/07/15/1016276952/the-pandemic-has-worsened-childhood-vaccination-rates-around-the-world

### The CDC has updated its mask guidelines for schools. Some states will listen, some won't

- The Centers for Disease Control and Prevention released guidance Friday saying vaccinated teachers and students no longer must wear masks inside school buildings to protect against the transmission of COVID-19.
- The guidance, issued amid falling infection rates and hospitalizations, recommends unvaccinated individuals, including children, should still wear masks and maintain 3 feet of social distancing.
- Some states have already dropped their mask mandates for schools, such as in Rhode Island. Meanwhile, California was quick to stand up against the CDC's new guidance, announcing that masks will be worn when classrooms open this fall. The decision, in part, is to "ensure that all kids are treated the same," whether vaccinated or unvaccinated, the state's Department of Public Health said in a statement.
- Other states aren't issuing mask requirements but will allow individual school districts to determine whether they want students to wear masks.

#### 'Facebook isn't killing people' — Biden walks back attack over vaccine lies

- President Biden walked back some of his criticism of Facebook, saying he meant to accuse a dozen social media platform users, not Facebook itself, of "killing people."
- Biden added that he hopes Facebook will do more to fight "the outrageous misinformation" about coronavirus vaccines being spread on its platform "My hope is that Facebook, instead of taking it personally that somehow I'm saying Facebook is killing people, that they would do something about the misinformation, the outrageous misinformation about the vaccine." "That's what I meant," the president said.

#### The COVID symptoms to look out for if you are fully vaccinated

- Although being vaccinated against the coronavirus provides protection against severe illness and hospitalization, fully vaccinated people who test positive for COVID-19 can still experience symptoms.
- Based on reports from people infected with the coronavirus noted in the Zoe COVID symptom study, the five most common symptoms among fully vaccinated people with the virus are:
  - Headache
  - o Runny nose
  - Sneezing
  - Sore throat
  - o Loss of smell
- While some of these symptoms present themselves in individuals regardless of vaccination level, <u>the study</u> showed that most of the previously dominant COVID signs — such as persistent cough — are more likely to appear in unvaccinated individuals or those who just received one shot.
- Sneezing is the one symptom on the list that presents itself in partially vaccinated and fully vaccinated individuals, according to the study, and is the one symptom that is <u>not listed on the Centers for Disease Control and Prevention (CDC) website</u>.
- However, these breakthrough COVID-19 cases are rare, especially given that the <u>Moderna</u> and <u>Pfizer</u> vaccines are close to 95% effective in preventing against symptomatic infection while the <u>Johnson & Johnson</u> vaccine is about 66% effective. <u>https://www.nj.com/coronavirus/2021/07/the-covid-symptoms-to-look-out-for-if-you-are-fully-vaccinated.html</u>

### Essential California: The mask mandate is back in L.A.

- With coronavirus cases among unvaccinated people rising to distressing levels, L.A. County health officials will again require all residents, regardless of their vaccination status, to wear a mask in indoor public spaces. The mandate will go into effect late Saturday night.
- Although overall case counts remain relatively low compared with earlier in the pandemic, there has been a sizable increase in cases and hospitalizations in L.A. County. Similar jumps have also happened in Orange, San Diego and San Bernardino counties.
- Given the upward trend, and the presence of the highly infectious Delta variant, local health officials said they couldn't wait to act — and that more extreme steps might be necessary down the road.






