Israel offers COVID booster vaccine for ages 12 and above

- Israel has begun offering a COVID-19 booster to children as young as 12, and its prime minister says a campaign that began a month ago among seniors has slowed a rise in severe illness caused by the Delta variant.
- Announcing the decision on Sunday, top Israeli health officials said the effectiveness of the second dose of the Pfizer-BioNTech vaccine waned six months after administration, making a booster necessary.
- "The third dose brings us to the level of protection achieved by the second dose, when it was fresh," said Sharon Alroy-Preis, head of public health at Israel's Health Ministry. "That means, people are 10 times more protected after the third vaccine dose," she told a news conference, where the expanded booster drive was announced.

Japan suspends 1.63 million Moderna doses over contamination

- Japan has suspended the use of 1.63 million doses of Moderna's COVID-19 vaccine after reports of contamination in several vials, drugmaker Takeda and the health ministry have said.
- Takeda Pharmaceutical Company, which is in charge of sales and distribution of the Moderna shot in Japan, on Thursday said it had "received reports from several vaccination centres that foreign substances have been found inside unopened vials".
- "We have not received reports of health problems stemming from the foreign object," he told reporters. "But we are asking people to consult their physicians if they experience any abnormality." There had been no "concrete reports" that doses confirmed to contain contaminants had been administered. The firm said it had informed Moderna and "requested an urgent investigation".

 Moderna did not immediately respond to a request for comment.

- Pfizer's two-dose Covid-19 vaccine has received full approval from the US Food and Drug Administration (FDA) the first jab to be licensed in the nation.
- It still has emergency use authorization for children aged 12 to 15.

4-Year-Old Child Dies From COVID In Riverside County

- RIVERSIDE COUNTY, CA A 4-year-old child from Western Riverside County recently died after contracting COVID-19, becoming the youngest person in the county to die from the virus since the pandemic started, county officials announced Friday.
- The child had no underlying health issues, the officials said.
- The death took place during the first week of August, but health officials reported the cause of death this week after receiving confirmation from the coroner's office. The name of the child and city of residence are not being released.
- To date, 46,992 COVID-19 cases have been reported in kids ages 0-17; in the 18-24 age group, 45,305 cases have been reported, according to RUHS.

Education Dept. Announces Civil Rights Investigations Into 5 States' Mask Mandate Bans

- The U.S. Department of Education sent a warning to five states on Monday that their statewide bans on mask mandates, including in schools, could violate students' civil rights. Suzanne B. Goldberg, the department's acting assistant secretary for civil rights, sent letters to state education leaders in Iowa, Oklahoma, South Carolina, Tennessee and Utah, informing them that the department's Office for Civil Rights is investigating whether their bans are discriminatory.
- At the center of the department's concerns, according to Monday's letters, are students with disabilities who may be at heightened risk for severe illness from COVID-19. Goldberg's letters say these investigations will focus on whether the state bans are discriminatory by preventing students with disabilities from safely returning to in-person education.
- If students with disabilities do not feel safe returning to school because their classmates cannot be required to wear masks, the department's argument goes, then these bans could be considered discriminatory and violate either Section 504 of the Rehabilitation Act of 1973 and/or Title II of the Americans With Disabilities Act of 1990.

Wuhan lab leak theory: How Fort Detrick became a center for Chinese conspiracies

- A disinformation campaign claiming that the Covid-19 virus originated from an American military base in Maryland has gained popularity in China ahead of the release of a US intelligence report on the virus origins.
- In May, President Biden ordered a 90-day probe into whether the Covid-19 virus came from a lab accident or emerged from human contact with an infected animal. Until then, the "Wuhan lab leak" theory had been dismissed by most scientists as a fringe conspiracy theory. As the report is due to be released, China has gone on the offensive. In the past few weeks, Chinese sources have been amplifying a baseless claim that Covid-19 was made in the US.

Can the US crack down on fake vaccination cards?

- As more people in the US are asked to prove they have been vaccinated in order to work, study or socialize, a flourishing black market in fake vaccination cards has sprung up.
- The operator behind "Covid19vaccinecardsss" took just seconds to reply. One of a slew of Instagram accounts hawking fake proof of Covid-19 vaccination cards, inviting the BBC to move over to an encrypted messaging app to make a deal. For \$100, the vendor would deliver a "registered" card, with either the logo of the US CDC or Britain's National Health Service. Payment could be made in Apple Pay or Bitcoin and delivery would be "discrete" and within 24 hours, they promised. "Your cards will be saved into the database system," they told the BBC. "These are very good original vaccine cards, no worries."
- Last week, customs officials seized 6,000 false vaccination cards in separate shipments from China destined for recipients across
 the US. They were printed with the CDC logo and closely resembled the genuine cards given to US citizens when they are
 vaccinated.

A judge asked a mother if she got the covid vaccine. She said no, and he revoked custody of her son.

- When Rebecca Firlit joined a virtual court hearing with her ex-husband earlier this month, the Chicago mother expected the proceedings to focus on child support.
- "One of the first things he asked me . . . was whether or not I was vaccinated," Firlit, 39, told the Chicago Sun-Times.
- She was not, she said, explaining that she has had "adverse reactions to vaccines in the past" and that a doctor advised her against getting the coronavirus vaccine.
- Cook County Judge James Shapiro then made what the parents' attorneys called an unprecedented decision he said the mother could not see her 11-year-old son until she got the vaccine.
- The judge then revoked her custody of her son until she was fully inoculated.
- Judges in other states have granted lesser sentences to defendants who opt to get the vaccine, or mandated the vaccine as a condition of release from prison for some inmates. https://www.yahoo.com/news/judge-asked-mother-she-got-091759242.html

As Schools Reopen, Child Psychiatrists Expect To See A Surge Of Kids Who Need Help

- "Historically, our busiest times of the year are a couple of weeks into the school year, perhaps the end of September, beginning of October," says <u>Dr. Richard Martini</u>, a child and adolescent psychiatrist at the University of Utah and Primary Children's Hospital in Salt Lake City. "These are times where you really begin to identify kids that are struggling the schools begin to identify them."
- A significant number of calls from schools requesting education and professional development for teachers around how to support kids with trauma.
- According to the CDC, between March and May, 2020, hospitals across the country saw a 24% increase in the proportion of mental health emergency visits by kids aged 5 to 11 years old, and a 31% increase for kids 12 to 17.

IL School Children Can Now Miss Class For Mental Health: New Law


- Students statewide may now take up to five mental health days per year without a doctor's note, according to a new law signed by Gov. J.B. Pritzker last week.
- Senate Bill 1577 amends the compulsory attendance clause of the state school code to include mental and behavioral health as valid reasons to miss school. If a student misses class for an excused reason, they will be given the opportunity to make up school work, according to the text of the law.
- "It's critical that schools are offering support to students who struggle with their mental health," she said in a statement. "Just as we would allow a student with a cold or fever to stay home from school, students should be able to have the same treatment for days where they need a break for their mental health."
- The bill, which also encourages schools to connect students with mental health resources, passed the Illinois House and Senate unanimously.




COVID-19 Vaccine Booster Shot When can I get a COVID-19 vaccine booster?

Not immediately. The goal is for people to start receiving a COVID-19 booster shot beginning in the fall, with individuals being eligible starting 8 months after they received their <u>second dose</u> of an mRNA vaccine (either <u>Pfizer-BioNTech</u> or <u>Moderna</u>). This is subject to authorization by the U.S. Food and Drug Administration and recommendation by CDC's Advisory Committee on Immunization Practices (ACIP). FDA is conducting an independent evaluation to determine the safety and effectiveness of a booster dose of the mRNA vaccines. ACIP will decide whether to issue a booster dose recommendation based on a thorough review of the evidence.









What Is a Post-Vaccination COVID-19 Case?

Post-vaccination cases are defined as individuals who are fully vaccinated and have a positive SARS-CoV-2 molecular (e.g. PCR) test 14 days or more after they have completed their full one-dose or two-dose COVID-19 vaccination series. They are also referred to as vaccine breakthrough cases.

How Are Post-Vaccination COVID-19 Cases Identified?


The California Department of Public Health (CDPH) is identifying post-vaccination cases by analyzing the immunization and case registries to find individuals who have a positive SARS-Cov-2 molecular test at least 14 days after they have completed their full vaccination series. Local Health Jurisdictions (LHJs) are also encouraged to alert CDPH of post-vaccination cases especially if they result in severe disease (e.g., hospitalization or death) or if they are associated with an outbreak.

What Is the Current Data on Post-Vaccination Cases in California?

For the week of August 16-22, the average daily COVID-19 case rate among unvaccinated Californians is 51 per 100,000 and the average daily COVID-19 case rate among fully vaccinated Californians is much lower at 7.2 per 100,000

Between January 01, 2021 and August 22, 2021 in California,

- Out of over 22.2 million fully vaccinated individuals, 93,646 post-vaccination cases (0.4%) have been identified.
- At least 2,331 individuals identified as post-vaccination COVID-19 cases were hospitalized. However, it is important to note that approximately 65 % of cases have missing hospitalization data. It is also important to note that a post-vaccine case may have been hospitalized for a condition unrelated to COVID-19 reason but were tested for COVID-19 upon admission.
- Among post-vaccination cases identified, at least 239 people have died. However, it is unknown if the primary cause of death in these cases was COVID-19 or if there were other contributory or alternate causes.

Atlantic Overview TROPICAL OUTLOOK









